ORDINANCE NO. 22-156.05

AN ORDINANCE TO AMEND CHAPTER 2, "ADMINISTRATION," ARTICLE V, "BOARDS AND COMMISSIONS," DIVISION 3, "BOARD OF REVIEW," SECTION 2-193.6, "GUIDELINES TO BE UNIFORMLY APPLIED," RELATING TO POVERTY EXEMPTIONS, IN ORDER TO REVISE THE STANDARDS FOR UNIFORM APPLICATION OF EXEMPTION PROVISIONS TO COMPLY WITH STATE LAW REQUIREMENTS.

THE CITY OF NOVI ORDAINS:

Part I. That Chapter 2, Administration, Article V, Boards and Commissions, Division 3, Board of Review, Section 2-193.6, Guidelines to be uniformly applied; exceptions, shall be amended to read in its entirety as follows:

Sec. 2-193.6. - Guidelines to be uniformly applied.

The board of review shall uniformly apply the provisions of this chapter, to each applicant for a poverty exemption and so that a twenty-five (25) percent, fifty (50) percent or one hundred (100) percent exemption is granted.

Section 2 of Ordinance. Repealer.

All ordinances, parts of ordinances, or sections of the City of Novi Code of Ordinances in conflict with this Ordinance are repealed only to the extent necessary to give this Ordinance full force and effect.

Section 3 of Ordinance. Severability.

Should any section, subdivision, clause, or phrase of this Ordinance be declared by the courts to be invalid, the validity of the Ordinance as a whole, or in part, shall not be affected other than the part invalidated.

Section 4 of Ordinance. Savings.

All proceedings pending and all rights and liabilities existing, acquired or incurred at the time this Ordinance takes effect, are saved and may be consummated according to the law in force when they were commenced.

Section 5 of Ordinance. Effective Date.

This ordinance shall be effective upon publication in the manner prescribed by law.

Section 6 of Ordinance. Enactment.

This Ordinance is declared to have been enacted by the City Council of the City of Novi at a meeting called and held on the 14th day of March, 2022, and ordered to be given publication in the manner prescribed by law.
