WHEREAS, On May 27, 2023, the Committee received a report from the Foresite Group, addressing the initiation of local broadband and telecommunications market assessment; gap analysis (understanding where internet access gaps exist in Novi); business case needs assessment; regulatory environment assessment; and

WHEREAS, the Foresite Study was submitted to and received by the City Council; and
