Proclamation in recognition of National Letter Carriers' Food Drive Day, May 14th –

Mayor Gatt presented the proclamation to Sherri McIntosh. Ms. McIntosh thanked Mayor Gatt and City Council. It is the 24th year of the food drive. Letter Carriers' nationwide have collected over 1.4 billion pounds of food. All the food stays in Novi and goes to the food pantries at Faith Community Church and St. James Catholic Church. AUDIENCE COMMENT:

Stephen Genyk, 20934 E. Glenhaven Cir., spoke about the Water Department's access road to the lift station between Normandy Hills and Country Place. He noted the access is through a parking lot since 1973. The access road is flanked by a retaining wall and an in ground transformer. The distance between the building structures is 20 feet. His concern was most of the vehicles are too large to get under the utility wires. He noted there is another access to the east. He suggested going near the Normandy Ct. route since there wasn't any obstructions rather than Country Place.

MATTERS FOR COUNCIL ACTION

1. Consideration of requests from JD Racing Indoor Karting, LLC:

- A) Consideration of a request for Special Land Use approval for service of alcoholic beverages.
- B) Consideration of request to transfer ownership of escrowed 2015 Class C License with New Entertainment Permit and Sunday Sales Permit (AM & PM) from Fresco Foods, Inc., 145 S. Milford Road, Milford, MI 48381 to JD Racing Indoor Karting, LLC, an existing business located at 44225 W. Twelve Mile Road, Novi, MI 48377.

Member Mutch asked how the liquor license would be utilized. Linda Mayer and Mark Dick, representing JD Racing Indoor Karting, LLC replied that they had been using a catering service when large groups would come in for their food and beverage services and that the catering service had carried the license. Mark Dick said the liquor license would be used predominantly for social and business events. He mentioned they have been operating for three and one half years without incident. Mark Dick said the only change that would take place would be that the license will be carried under their name instead of the catering service from Ferndale. The patrons will not notice any change.

Mayor Pro Tem Staudt commented that he had a corporate event there in the past and they were very careful on whom they served alcohol to. He remembers the difficulties working with the caterer as opposed to working directly with JD Racing and gave them full support.

CM 16-05-052 Moved by Staudt, seconded by Burke; UNANIMOUSLY CARRIED:

2. Approval of resolution to authorize Budget Amendment #2016-3.

Member Mutch questioned City Engineer Rob Hayes on what the urgency was with the Water and Sewer Item in the budget amendment regarding the Nine Mile Road Gravity Relief Sewer Project along Nine Mile Road from Beck Road west towards Napier Road. He wondered why it wasn't part of the normal budgeting process. Mr. Hayes explained that we are facing a capacity issue and we are unable to approve any new developments that would be in that service area. He said it is feasible for us to add a handful of individual grinder pumps for individual residential units, but that would be the extent of it. He mentioned if allowed to go forward with the project, it would give us a gravity sewer that would be reliable. It would be relatively maintenance free and also would function for many decades to come. Member Mutch commented that in the packet a few weeks ago, it mentioned a capacity issue and it noted that Wayne County wouldn't let us do two parallel lines if it is a forced main, because they viewed this as doubling the capacity. Member Mutch wondered if this would replace the other line or will the other line still stand? Mr. Hayes explained we would use a portion of the forced line because we need a portion of the forced main to discharge out of Park Place, but then from that point east, would be abandoned and will go gravity. Member Mutch confirmed with City Engineer Hayes that there would be no redundancy, just lower maintenance costs. Member Mutch asked who would be responsible for the cost if certain users change the connection from the line. City Engineer Hayes said that it would be the responsibility of the individual owners who would hire a plumber to handle the disconnection and the City would assist with the actual connections to the gravity main. Member Mutch mentioned individuals would not have a choice and that this would have a big impact and wondered what the cost would be to change the connections. City Engineer Hayes said he did not have the numbers, but he would look into it. Member Mutch wondered if the alternate service area for this line would include all or part of the Links of Novi. City Engineer Hayes said that the Links of Novi was a potential depending on how that side was designed. Member Mutch confirmed with City Engineer Hayes that the rest of the line would be along the Nine Mile Road Corridor. Member Mutch said he understood when the users connect, they pay a standard tap fee that would be separate and that it did not cover the cost of this particular line. Member Mutch asked if \$3.8 million dollars would come from the existing Water and Sewer Funds. City Engineer Hayes said that was correct and that \$750,000 came from two abandoned projects that aren't necessary at this time. Member Mutch wondered if the current users of the fund were paying for that. City Engineer Hayes said that was correct with the understanding, over time, that amount would be essentially reimbursed with the quarterly fixed charges that would accumulate over the years. Member Mutch said that this is a huge project in terms of cost which ultimately will serve a larger area which currently serves less than 200 homes and to put almost \$4 million investment in that area seemed significant with this parallel forced main. He wondered if there were any other alternative routes that the sewer line could go that would reduce the cost. City Engineer Hayes said that there was

nothing economically feasible and mentioned that we would have to go with possibly one or two huge pump stations to overcome the terrain to get it to flow to gravity to the nearest discharge point and that these were the only two options that seemed feasible. City Engineer Hayes added that when Council approved the City to survey this project, it opened our eyes to see how difficult it would be with either of the alternates, either the forced main or a gravity line. He said once a gravity line is in place, it will be reliable, be maintenance free, but it will be a deep sewer, out of sight and serve all the users who connect to it. Member Mutch said that he sees long term benefits, but he felt that it was a huge upfront cost for the City to bear to encourage additional development in the area and thought it was not a wise use of City resources in that area at this time. He said that most of Nine Mile Road is not paved and we do not have full range of city services in that area.

Member Mutch mentioned this particular Budget Amendment was also taking money from the Tree Fund. He said he previously raised his objections to utilizing the Tree Fund money outside of the Tree Fund. He said, having approved it for the next budget year, currently in this budget amendment, we actually are taking more money out of the Tree Fund with \$120,000 going towards maintenance activities. Member Mutch said that was money that developers paid to the City to replant trees that were removed during the development process. He commented that \$120,000 would be a lot of trees not being planted.
