BACKGROUND INFORMATION:

The City of Novi has planted over 4,000 trees within the City to replace ash trees and enhance public property using Tree Fund monies. In 2007, staff developed a Five-Year Tree Fund Planting and Utilization Strategy in effort to manage this urban forestry resource.

This spring, a total of 500 trees will be planted, staked, and mulched through this contract, which includes a two-year warranty on all trees and any required replacement trees. These trees will be planted primarily within residential subdivisions and I-96/Beck Road interchange. Approximately, 300 trees are scheduled to be planted within the re-constructed I-96/Beck Rd. corridor (aerials attached). The primary goal of these trees will be to enhance the aesthetics of this community gateway and will be coordinated with the Neighborhood & Business Relations Department to enhance the new gateway signage. Some other intangible benefits of the trees include reducing stormwater runoff, controlling erosion, reducing noise pollution, and acting as natural snow fences.

One key aspect of the project will be species diversification. A total of 19 different species will be planted as part of this contract. Staff will base tree selection on pertinent site factors, such as soil type, proximity to adjacent trees and other vegetation, the location of overhead and underground utilities, the exposure of the site and the amount of growing space available to support healthy tree growth and development. Staff will hand-select trees prior to planting to ensure specimen quality. These trees will be maintained as outlined per our Five- Year Tree Fund Planting and Utilization strategy.

The City received thirteen bids for this planting on February 28, 2008. Staff reviewed the bids and investigated jobs performed by Panoramic Landscaping and are satisfied that they can meet our quality standards. Panoramic Landscaping has been installing quality trees for 23 years in several communities such as the City of Novi, City of Northville, City of Farmington, and Hartland Township.

The planting is expected to commence in April and be complete in June 2008. Adjacent property owners will be notified of the planting and receive tree care instructions. Please reference the attached documents for more detailed bid information.

Below, please find the tabulation of bids opened on February 28, 2008, for the tree planting program. The City received thirteen bids with one later being withdrawn (Lodi Farms). Staff have investigated projects performed by these organizations and recommend that the award be given to Panoramic Landscaping, Inc. of Novi, MI.

The low bid was Greg Davis Landscape Services but staff are not recommending them because they submitted an incomplete bid (no bid 2 alternate A unit cost as required per specifications) and staff were unsatisfied with their overall performance last spring. Examples include unfamiliarity with the scope and specifications of the contract resulting in disputes with staff, unresponsiveness to several staff concerns, and submitting several incorrect invoices resulting in staff dedicating several hours correcting them (even) after contractor re-submittals).

Based on the information cited above, it is our recommendation that this contract be awarded to the next lowest bidder, Panoramic Landscaping, Inc., in the amount of \$ 95,580.00. Panoramic is a local company (Division of Glenda's Garden Center) that has been planting trees for the past 23 years, including the City of Novi and several Novi developers such Singh and Mirage Development. Therefore, they are familiar with our specifications, requirements, and expectations.

The tree planting program includes planting a variety of different species along major roads and subdivisions where trees were removed. Additionally, trees will be planted within I-96/Beck Road corridor to enhance the aesthetics as part of the Five-Year Tree Fund Planting and Utilization Strategy. The plantings are expected to commence in April and be completed in June. Residents will be notified of the plantings. Funds for the plantings will come from the tree fund account and various escrow accounts for approximately \$92,580.00 and \$3,000 respectively.




