SUBJECT: Approval of Traffic Control Order 08-07 for the installation of a No Thru Traffic sign on southbound West Park Drive at 12 Mile Road.

BACKGROUND INFORMATION:

The Novi Police Department has requested the installation of a No Thru Traffic sign at the entrance to Keystone Medical Facility as Patrol Officers have observed the following driving conditions/habits in this area:

- Heavy southbound traffic on West Park Drive during evening commuting hours.
- Some motorists wishing to make a left-hand turn onto eastbound 12 Mile Road from West Park Drive are not utilizing the left-turn lane; they are going straight through the intersection into the Keystone Medical Facility, and speeding through the parking lot in order to turn right onto eastbound 12 Mile Road.
- Southbound motorists are using the private parking lot to turn east on 12 Mile Road from West Park Drive rather than wait in the left-hand turn lane.

A No Thru Traffic sign would help effect proper and safer driving procedures at this intersection.

RECOMMENDED ACTION: Approval of Traffic Control Order 08-07 for the installation of a No Thru Traffic sign on southbound West Park Drive at 12 Mile Road.

Christine,

Per our phone conversation, there is a problem with the following intersection, as follows:

- 1. Southbound traffic on West Park Drive gets heavy during the evening commute.
- Some motorists wishing to make a left hand turn onto eastbound 12 Mile Road from southbound West Park Drive are not getting into the left hand turn lane to wait but are going through the intersection (straight) into the Keystone Medical Facility (on the south side of 12 Mile Road).
- 3. Then the motorists are traveling fast through the parking lot; eastbound to the Keystone's eastern most exit, and then turning right onto eastbound 12 Mile Road.
- 4. In this way, the southbound motorists are using the private parking lot to go east on 12 Mile from West Park Drive, rather than waiting in the left hand turn light.

I think that a **NO THRU TRAFFIC** sign with orders at the entrance to Keystone Medical is in order, to effect proper driving habits in the area.

Additionally, the Left Turn Signal at Southbound West Park Drive needs additional seconds for motorists to make that left turn and move / flow the traffic better.

I have cc'ed a copy of this to RCOC (Danielle Denoe) for consideration of the additional seconds.

It appears to be more concentrated between 5 PM and 6 PM. So the additional seconds may assist (at that time) in the flow of traffic without motorists using private property to avoid the backup.

Please let me know if there is anything I can do to assist in this endeavor. Thank you.
