SUBJECT: Approval of the final balancing change order and final payment to Koala-T Construction Company, Inc. for the 2007 Sidewalk Construction program in the amount of \$9,045.10.

BACKGROUND INFORMATION:

The city's consulting engineer for this project (Anderson, Eckstein & Westrick) administered this construction contract for constructing sidewalk segments throughout the city in 2007 and continuing into early 2008. This project included the construction of eight gaps in the Novi pathway system totaling approximately 4,700 lineal feet along portions of Nine Mile Road (between Taft Road and Beck Road), Ten Mile Road (between Taft Road and Beck Road) and Meadowbrook Road (between Eight Mile Road and Ten Mile Road).

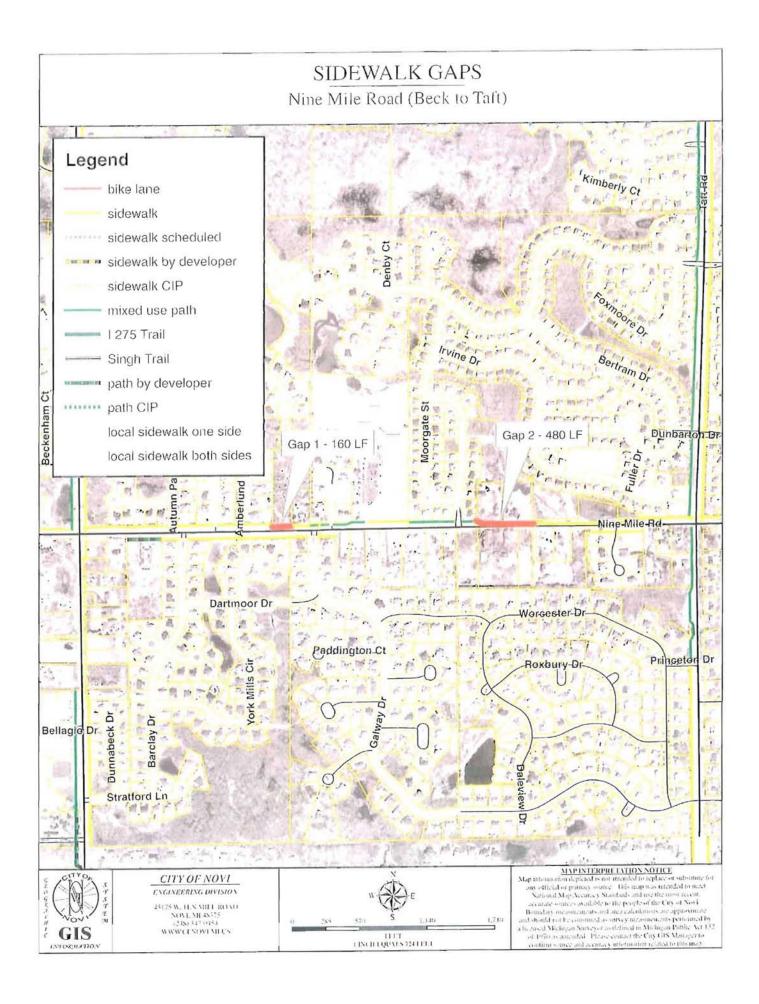
AEW has executed and submitted the attached documents verifying the final contract payment amount that is due to the construction contractor, Koala-T Construction, Inc. (AEW's Final Pay Estimate No. 4, and Final Balancing Change Order No. 2, attached).

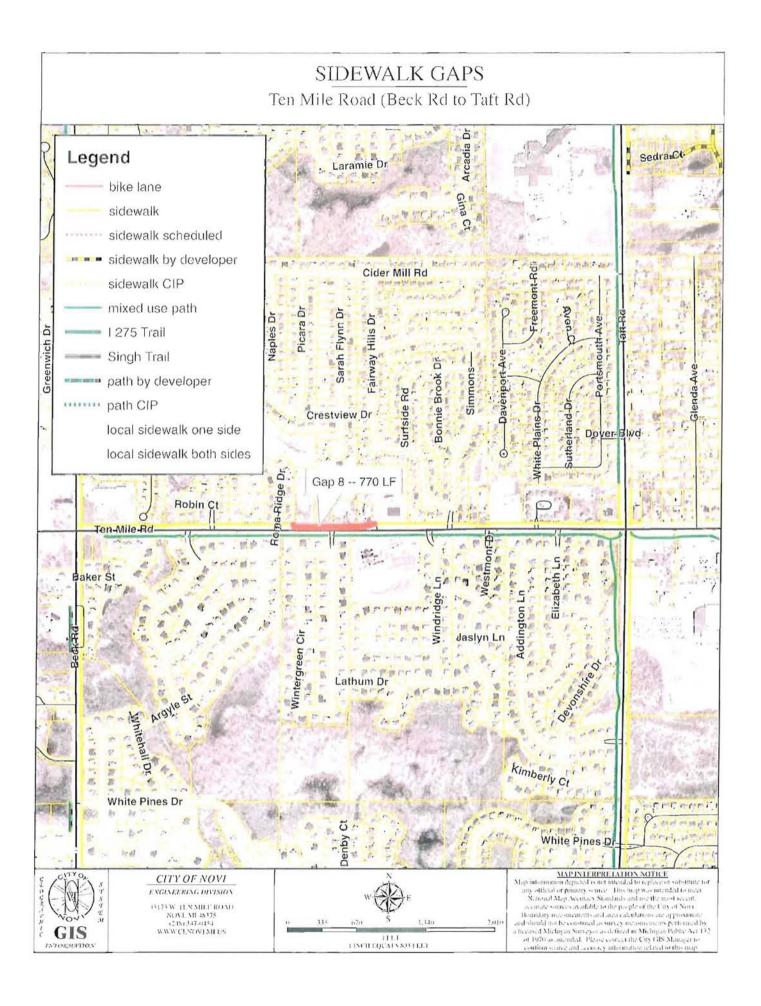
The sidewalk construction work performed by the contractor was in substantial compliance with the plans and specifications, and final payment in the amount of \$9,045.10 is appropriate. In addition, the City Attorney has reviewed supporting documentation and found it to be in an acceptable form (Beth Kudla's September 12, 2008 letter, attached), with the exception of two items that have since been addressed by the contractor. The original contract was approved at the July 2, 2007 City Council meeting in the amount of \$180,902. The final payment brings the total in construction expenditures on this project to \$228,390.80. The major change orders on this project included adding a section of wooden boardwalk to the project, and making significant drainage improvements to several areas along Meadowbrook Road.

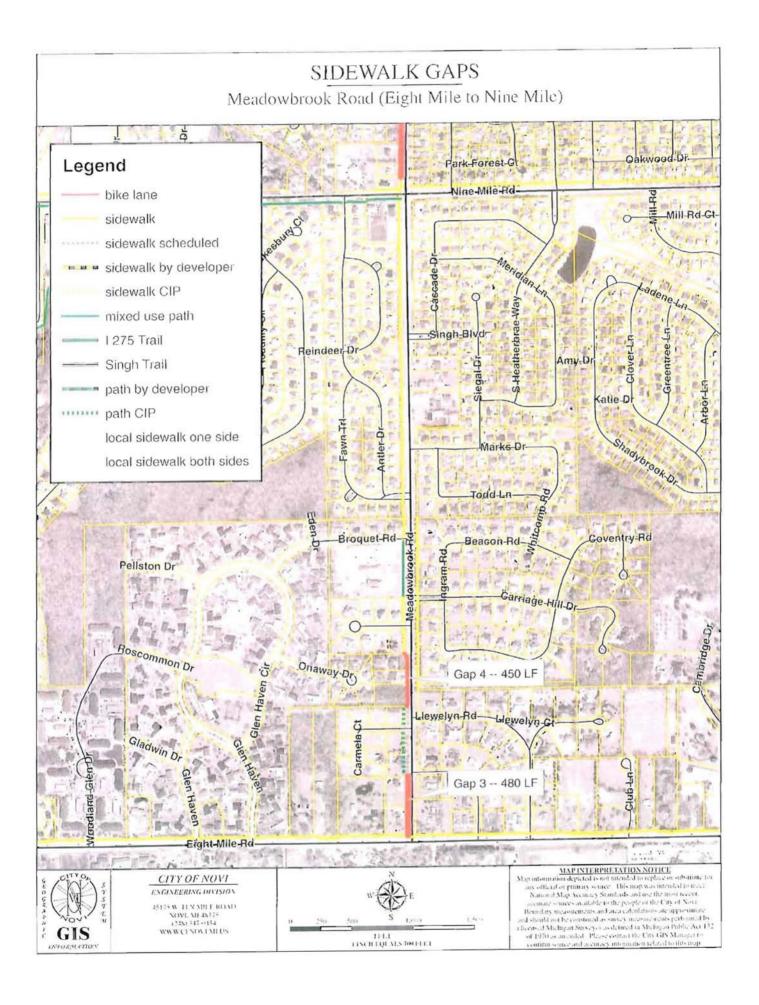

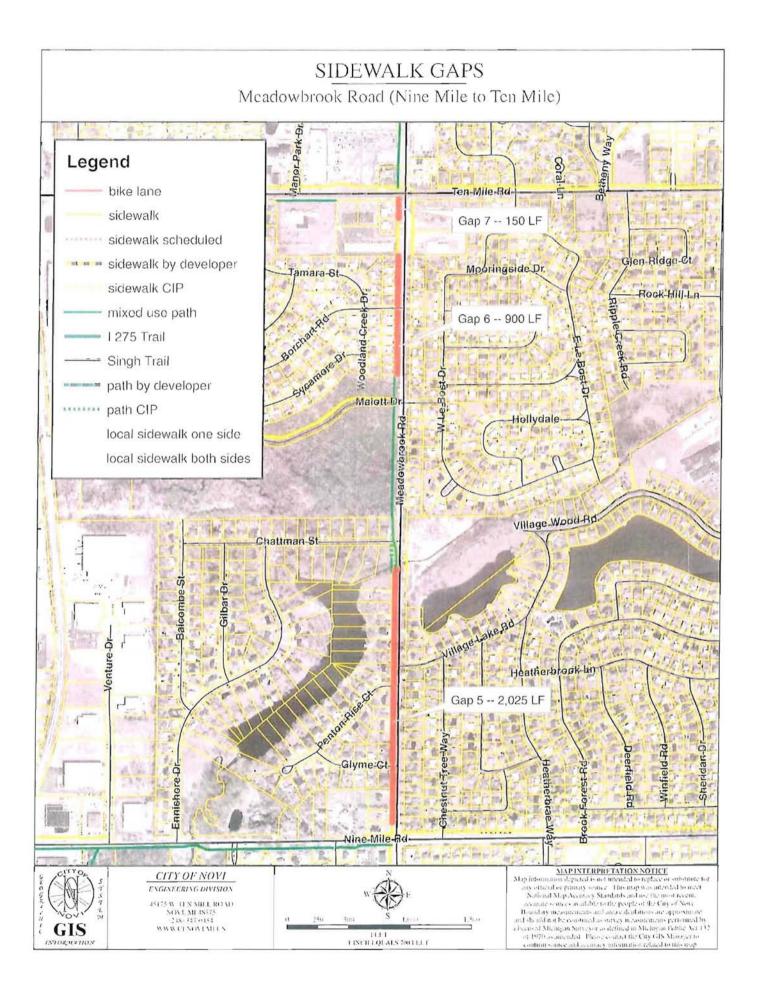
