The proposed program year (PY) 2010 planning allocation for the City of Novi is estimated to total \$100,547. This represents an overall reduction of \$51,707 from 2009. Increased funding for 2009 in the amount of \$152,254 was achieved as a result of action taken by City Council to accelerate the repayment of future program income funds in the amount of \$34,473 into the 2009 Minor Home Repair Program.

UPDATE - Program Year 2010 Reduction in Public Service Cap. Oakland County is required by HUD to maintain an overall public service cap of 15%. Dating back to November 1, 1996, Oakland County was allowing participating communities to spend a maximum of 50% of its annual allocation for public service activities and still maintain the overall 15% requirement. This was possible because of the large offsetting Oakland County Home Improvement Program. The impact of the 2000 census was to eliminate the area wide benefit activities for many communities forcing more communities to now allocate funds directly to public service activities. As a result, Oakland County in 2006 changed their policy to only allow participating communities to spend a maximum of 45% of their annual allocation on public services. Recent economic events have resulted in the further erosion of the public service cap forcing community's to further reduce their allocation of funds within this category. Because of a sever decrease in the amount of revolving loan fund (RLF) paybacks to the Home Improvement Program, the public service cap was reduced even further by Oakland County to a maximum of 30% of community allocations. The impact of this action has forced Novi to cut total public service spending by \$15,336 or 34% from 2009. The public service category has allowed the City of Novi to fund programs and services such as senior transportation, senior manager, Youth Assistance and HAVEN.

The maximum amount the City of Novi is allowed to allocate to the public service program category in total for 2010 is \$30,164 (\$100,547 \* 30%), assuming our estimated grant award remains at \$100,547. *Funding requests for public service activities were received for 2010 totaling \$52,000.* 

HCD Committee Recommendation: Funding requests were reviewed by the Housing and Community Development Advisory Committee at their meeting of October 5<sup>th</sup> and they are recommending the following program allocations for 2010:

# The financial impact of this recommendation may result in an additional \$10,000 transfer from the City's General Fund to the Parks, Recreation & Cultural Services Fund (for the Senior Transportation Program) as compared to the prior year. There would be <u>no change</u> in the program delivery.

Recommendations to reduce overall public service spending to comply with the Oakland County mandated 30% cap was the main focus of the HCD Committee meeting held October 5<sup>th</sup>. Of the total Public Services allocation in the amount of \$30,164, the Committee is recommending the following distribution:

Letters requesting grant funding from HAVEN, Novi Youth Assistance, Senior Van Program and St. Vincent DePaul have been included within this packet as additional information.

Senior transportation is proposed to receive the majority share of available public service funding with 50% of the total allocation recommended to remain within this program service category. Novi Youth Assistance was allocated 30% with HAVEN recommended to receive the remaining 20%. In order to provide funding for new programs, further cuts would have had to be made within our current programs. Given the current state of our funding allocation, the Committee unanimously agreed not to recommend funding at this time for the St. Vincent de Paul Society. In addition, the Oakland County Community and Home Improvement Division has determined that Novi cannot award block grant funds directly to St. Vincent DePaul since this agency is not considered to be a sole source for the type of services they are providing.

The Committee agreed to recommend continued funding for the Novi Youth Assistance however recommended reducing their overall request by \$5,836 or 40% given the current state of mandated funding cuts. Funding dollars allocated to NYA are used to provide direct intervention services for Novi youth and include counseling, enrichment, skill building and academic support to children who are for various reasons deemed to be at "at risk" or whose families have insufficient financial resources to meet their needs for these activities. The broad goals are: 1) to provide scholarships to allow children (who qualify by income) to attend various summer camps according to their individual interest and needs, 2) to enroll qualifying children in programs that increase skills in various areas and 3) to provide tutoring to qualifying children who can benefit from additional academic support.

Our city-wide Minor Home Repair program has experienced tremendous success in past years. As of September 30, 2009, we have a total of **88** Novi residents who have qualified under our Minor Home Repair Program. As a result of leveraging our CDBG funds with the Department of Energy Weatherization Assistance Program grants, we are able to address the needs of **53** families who have already been approved under the Weatherization Program. By combining the additional funds approved in the 2009-10 Budget as a result of *accelerating the repayment of program income*, our 2009 Minor Home Repair Program totaled \$106,754 (see chart below). We have a total of 20 clients currently receiving assistance with these funds. We anticipate the need for this program to sustain throughout the 2010 grant year.

HAVEN Guidelines for CDBG Communities: Beginning with the 2007 Program Year, Oakland County now contracts directly with HAVEN as a sole source provider on behalf of participating communities. In the past, each community would contract individually with HAVEN. The contract duration period will be one year and at the end of the contract period, any community balance will be expended for the 24-hour crisis hotline. HAVEN has requested funding for 2010 in the amount of \$9,000. The Committee agreed to recommend continued funding for HAVEN however reduced their overall request by \$3,000 or 33%. HAVEN has reported last fiscal year a total of 254 Novi residents received direct assistance from HAVEN by way of shelter assistance, crisis intervention as well as services from HAVEN's Personal Protection Order Office.

**2000 Census Impact:** Enclosed with this packet is the 2000 census areawide benefit map. A comparison to the 1990 map shows census tract 1361, block group 2 which includes Lakeshore Park, no longer qualifies for CDBG funding of infrastructure type projects. The Recommended **Projects** for 2010 do not include any area benefit type projects such as parks, streets or sidewalk improvements. The projects are strictly city-wide individual income-qualified type projects such as minor home repair or direct benefit projects such as public services which are not dependent on census tract location.

September 30, 2009 Oakland County Community and Home Improvement Division Financial Report: Enclosed under "Additional Packet Material" is a CDBG Financial Report from Oakland County dated September 30, 2009. Since 2001, the City of Novi has received and *successfully managed over \$1,019,365* in CDBG grant funds.

# BACKGROUND

The Novi Senior Transit program began in February 1990 with one van funded by The Independence for Life Association and one part-time driver funded by Novi Parks and Recreation. The first full year of operation, we provided a surprising 3390 one-way rides. It soon became apparent that as residents discovered this essential new service, the demand would increase dramatically. In the past five years, we have provided an astonishing 66,286 one way rides.

City of Novi General Fund, CDBG, and SMART Municipal Credits funding have supported the program throughout its existence by providing vehicles as well as funding for operations.

The Senior Transit program currently operates a total of 7 vehicles:

Our transportation department employees include 3 part-time driver/schedulers and 10 part-time drivers.

The transportation program operates Monday through Friday from 7:30-4:30 pm and Saturday 9-2. Passengers may ride anywhere within the City of Novi for a nominal fee of \$3 per one-way ride and \$5 per one-way ride for up to 10 miles outside the city of Novi for medical appointments only. We have created a "punch card" for our passengers that allow them to purchase a card for \$30.00 which allows six one-way rides or six one way rides out of town. This card is used in place of cash, makes it easier for the passengers and ensures us of collecting fees. Transportation is provided to Novi residents only. Riders must be age 55 plus, or physically challenged of any age. We encourage residents to call 48 hours in advance by calling the Scheduler at (248) 735-5617.

NOTE: The City of Novi also subsidizes a demand-response type of transportation service via Community Cab. Riders must also be seniors or physically/mentally challenged non-senior residents of the City of Novi and will pay \$4 per one-way ride within the City limits. Regular rates apply outside the City. Reservations may be made by calling (248) 349-8118.

We continue to provide a safe and trustworthy senior transportation program to the senior population in Novi. For 2008/2009 we provided 11,333 one way rides for seniors and physically/mentally challenged non-seniors, collected \$25,238 in fares and provided 3,434 cab rides with our cab service. The numbers alone show how important this program is to our older adult community.

# FUTURE OF THE PROGRAM

In as much as there is no other public transportation in the City of Novi other than cab service and our Transit system, continued population growth, particularly in the age 65 plus group, create increased demands for transportation service. Numbers will continue to increase due to more and more seniors in our community relying on us to take them to their destination. Safety and health issues along with mobility problems with our older adults are a factor when they can no longer drive and can not find a way to medical appointments or to the drug store to get prescriptions show us this is becoming a bigger problem in our community. Our numbers are also increasing with passengers from other senior housing because they either do not offer any transportation and if they do, charge a higher fee or only have limited capabilities to transport to limited areas only. In addition, there are increasing numbers of non-senior Novi residents who, for health reasons, do not have transportation.

The cost of the transportation program continues to grow rapidly. In 2008/2009, cost of the program for both senior transportation and subsidized taxi was \$142,521. As you see from the above table, our fleet is aging, maintenance costs are up and mileage is getting high. As predicted, we anticipate the cost of the program to continue to grow. We would like to continue to receive the monies from the CDBG funding to help support this worthwhile program.

Dear Committee Members:

Novi Youth Assistance has received and utilized CDBG funding for moderate, low income and special needs youth since 1994. With continuing community support we have consistently honed our ability to identify at risk children who would benefit from recreational, educational and supportive programming. Once again this year, overall grant opportunities were reduced. In spite of this, we still insured a summer recreation program for Novi children at our own expense. Nonetheless, this along with a significant increase in requests for services has regrettably left us struggling, once again, to assist all applicants. As the sole local organization that can regularly provide comprehensive and varied scholarship opportunities within the City of Novi, we continue to find that demand is outpacing donations received. While we have made internal adjustments to stretch our monies as best we can, continued and increased CDBG funding is vital if we are to continue providing programming in 2010-2011 to those who otherwise might go unserved.

Due to the on-going economic downturn we are seeing record number of families requesting assistance with no end in sight at this time. This trend is ever increasing and a number of residents are struggling to provide the basics for their families. This then, inevitably eliminates any options to offer their children positive, healthy activities. Many of these children are then left with unscheduled time which leaves them at risk which, in turn, affects the community as a whole.

Historically, Novi Youth Assistance has been there to provide for those in need when there have been no other options. We continue to strive to do so. The benefit of offering summer programs, skill building activities and other supportive programming is demonstrated over and over again as we see these children move through the schools and community successfully. Therefore, in response to today's economic climate and rising costs, as well as demand for programming and decrease in other funding, Novi Youth Assistance respectfully requests that the members of the CDBG committee consider granting funds for the 2010 budget year in the amount of \$15,000.00.

The staff and counselors in this program work tirelessly to see that the needs of all children are met and their dedication is second to none.

Officers and Detectives from our department have partnered on many projects with Youth Assistance. We have staff that volunteers their own time to many events and programs put on by YA. Our people feel it is so important, they have spent time working with the Teen Center, Citizens Board, Short term Mentoring, Mentors Plus, Back to School Shopping and anything else that is needed. Again, I will stress they do much of this during their own time as they recognize the importance of Youth Assistance to our community. Without this valuable program, several at risk youth throughout our area would be formally charged in the juvenile court process.

As the Deputy Chief of Police, a long term Novi resident and a volunteer to Youth Assistance I strongly recommend the continuation of this very successful diversion program.

Violence in families is everywhere, crossing racial, ethnic, cultural, social and economic boundaries. The impact of this violence invades our schools, places of worship, offices, businesses, factories and throughout our neighborhoods. Human beings, both young and old, are being harmed physically, sexually and emotionally and this violence may be creating lifelong patterns of ongoing abuse in youngsters as they move into adulthood. We all pay the cost for the hortible crimes of domestic violence and sexual assault either in real dollars or in diminished potential of human and communicy life.

Since 1982, HAVEN has been dedicated to building violence-free communities one family at a time. HAVEN maintains a 24-hour emergency shelter exclusively for domestic violence victims and their children and sexual assault survivors who are afraid to stay in their own homes. HAVEN offers counseling and education that help families stop the violence, begin the process of healing, and create the hope that their future will be free from abuse. The agency steps out into the community – over the phone, in courtrooms, police stations, hospitals, schools, the work place, and at community meetings – to provide crisis intervention and education to help victims and families prevent violence in future generations. HAVEN staff manages the Personal Protection Order office located in the Circuit Court system, helping create and file Personal Protective Orders at no charge to the victims of abuse as the first step in their safety plan.

HAVEN through its comprehensive work serves to break the silence that has kept the crimes of domestic violence and sexual assault behind closed doors. This silence has only served to allow these crimes to flourish. From July 1, 2008 through June 30 2009, 199 individuals were seen within our programs and 55 crisis calls were received from families in the City of Novi who took the first step to break their own silence by contacting HAVEN. The agency is again reaching out of you for support of our work with an even greater need as we assume the additional burden of increased clientele and additional staff to maintain these vital services. We ask that you continue to support these families through a Community Development Block Grant of \$9000.00 for fiscal year 2010-2011. Piepse remember that the federal government presumes that domestic violence victims are considered to be low income and therefore qualify for inclusion in block grant public service requests
