#### **BACKGROUND INFORMATION:**

In January 2009, City Council awarded the bond consulting services for General Obligation and Revenue Bonds. However, the motion included a recommendation that quotes be sough for purposes of refunding bonds. As such, quotes were sought, and the low quotes were provided by:

Bendzinski & Company, total of \$18,990

Miller, Canfield, total of \$35,550

(Note: Prices above include costs for both issues)

The consultants provide support services throughout the issues and only invoice the City in the event bonds are actually issued. These fees are charged to the new respective bond issues and are included in the net present value savings computations.

Per your email we would propose to provide financial advisory services to the City of Novi to refund the 1999 Building Authority bonds for a all in price of \$9,800.00 and the 2001 Street Improvement bonds for a all in price of \$11,300.00. #### Kathy-

Thanks for your messages. Based on the refunding analysis, it appears the City is looking at two issues since there are different issuers (City and Building Authority) and different credits (UT vs. LT). Our fee for bond counsel would be as follows:

approx. \$5.0 million UTGO Refunding Bonds = \$22,500 approx. \$3.0 million Building Authority Refunding Bonds = \$17,000

In the event the City does both issues at the same time, there will still be two totally separate transactions and documents, but we would discount our fees by 10%.

#### With the 10% Discount

approx. \$5.0 million UTGO Refunding Bonds = \$20,250 approx. \$3.0 million Building Authority Refunding Bonds = \$15,300
