# **BACKGROUND INFORMATION:**

The gasoline contract bid is a joint bid with seventeen (17) other communities through the MITN Cooperative. Our estimate for yearly usage is 159,000 gallons of Mid-Grade (89 Octane) unleaded gasoline and diesel fuel. The estimated annual cost is \$287,000 based on usage in 2009.

Unit pricing is based on the market price on the day of delivery plus a pre-determined bid factor. The bid factor award for regular unleaded gasoline is \$0.0236/gallon added to the Oil Price Information Service (OPIS) daily average for Detroit. For example, on November 24, 2009 the OPIS daily average for regular unleaded gas was \$1.9919/gallon. After adding the bid factor of \$0.0236/gallon, the cost per gallon for a delivery on that day would have been \$ 2.0155/gallon.

Contract renewal period is 2/1/10 - 1/31/12.

## **Executive Summary:**

The City of Sterling Heights purchases approximately 225,000 gallons of gasoline and 100,000 gallons diesel fuel per year to power the City's fleet of automobiles, trucks, equipment and generators.

The City is also the host community for a Michigan Intergovernmental Trade Network (MITN) cooperative gasoline and diesel fuel bid that includes 20 member communities in the Macomb, Oakland and Wayne County region. Through this cooperative bid, approximately three million gallons of gasoline and one million gallons of diesel are purchased every year.

In January, 2008, City Council split the award of the bid to Mansfield Oil Company for tank wagon (greater than 5,000 gallons) deliveries and RKA Petroleum Companies for truck transport (less than 5,000 gallons) deliveries.

In the original bid, there was an option to extend the contract for the purchase of gasoline, diesel and alternative fuels for a two-year period at the unit prices competitively bid through MITN. To exercise this option, both the City and the vendor must agree to the two-year extension. At this time, recommendation is being made to extend the contracts through January 31, 2012 for the following reasons:

• Upon review of the current State of Michigan MiDeal bid (August 1, 2005 to August 1, 2010), the MITN cooperative bid hosted by Sterling Heights is lower in overall price for both gasoline and diesel fuel, and will produce a yearly savings for Sterling Heights of approximately \$8,599. The consensus of the cooperative is to extend the contract.

- Attached are signed contract extensions pursuant to which current vendors Mansfield Oil Company and RKA Petroleum have agreed to honor the terms and conditions of the MITN cooperative bid for an additional two-year period. Both vendors have performed very well over the last two years.
- Mansfield Oil Company continues to declare MITN cooperative members as "Critical Vendors", which helps assure uninterrupted deliveries of fuels to municipalities during a natural disaster.

#### **GENERAL INFORMATION:**

On December 11, 2007, bids were received in response to a MITN cooperative bid solicitation for the delivery of gasoline, diesel and alternative fuels. On January 16, 2008, City Council awarded the cooperative bid as follows:

In the original bid, there was an option to extend the contract for an additional two years, upon mutual agreement.

Funds for the purchase of gasoline and diesel fuels are budgeted in Account #11717553-750000 (Fleet Maintenance - Fuels and Lubricants). It is estimated that the City of Sterling Heights will expend approximately \$670,000 annually for truck transport and tank wagon deliveries of gasoline, diesel and alternative fuels.

#### STAFF ANALYSIS AND FINDINGS:

At this time, recommendation is being made to extend the contracts with each current vendor through January 31, 2012.

Pursuant to the consensus of the cooperative members for a contract extension, Mansfield Oil Company (truck transport deliveries) and RKA Petroleum Companies (tank wagon deliveries) have agreed to a two-year extension of the fuel purchasing contracts at unit prices stated in their bids of December 2007. Attached are copies of the original bids and the signed extension agreements.

Final review and approval by the City of Sterling Heights City Council will take place December 1, 2009. Cooperative members will receive confirmation via e-mail after December 1.

Please note the following when reviewing your invoices:

1. The cooperative agreed to pricing based on the OPIS Rack Average (Detroit) on the day of delivery, plus (or minus) the per gallon unit price bid per gallon, multiplied by the number of gross gallons delivered.

2. Starting January 1, 2009 the Federal Oil Spill Recovery Fee increased from \$0.0012 / gal. to \$0.0019 / gal. Be advised that the unit price bid per gallon includes delivery <u>and</u> any and all state and federal surcharges / fees. This or any other fee or increase cannot be passed on to the cooperative members.

3. Recently, RKA Petroleum attempted to add a \$100 to \$150 per delivery generator fill fee on deliveries less than 250 gallons. While the 2007 bid specifications listed a minimum of 250 gallons, RKA in their bid went beyond the minimum and stated that they would deliver <u>any</u> quantity requested by the cooperative members. As such, RKA cannot bill any such fee for deliveries less than 250 gallons. However, we are asking cooperative members to not abuse these smaller quantity orders and use discretion when making such orders.

Mansfield Oil Company, a national wholesale supplier of gasoline and distillate products, is a major supplier to Federal, State, County and Local government entities throughout the United States. Over the past few years Mansfield has implemented and enhanced upon a disaster recovery plan that not only covers our internal office procedures but covers the necessary steps to protect our customer's needs as well. While much attention has been placed on natural disasters in the gulf coast region of our country Mansfield realizes that natural disasters can occur anywhere and at any time. 
