

BACKGROUND INFORMATION:

The City of Novi currently maintains a multi-location telephone system service plan supporting city-wide operations at the Civic Center, Police Department, DPS, Fire Station #1, Fire Station #2, Fire Station #4 and Meadowbrook commons facilities. The communication network provides the public direct access to over 250 lines servicing all operational service areas. The telecommunications equipment supported under this agreement is a central component needed to achieve this goal and maintaining our current level of service to the public.

The initial, two-year, competitively bid agreement with Suntel Services signed in 2008 included a two year renewal as part of the bid process. The two-year renewal will result in a 0% increase in service costs therefore honoring the same annual rate paid in 2008 and 2009. We have also accounted for the transition from the Community Development satellite office thereby reducing our annual costs by \$1262. The renewal agreement includes maintenance on all components, parts, phone sets, labor costs, problem resolution support services, voice mail support, remote diagnosis, and alarm monitoring, priority response, and emergency protection for major critical failures twenty four (24) hours a day as described in the proposed service plan renewal for your consideration.

Attached you will find the motion sheet adopted in 2008 with the proposed contract terms through May 2012 with Suntel Services.

BACKGROUND INFORMATION: The City of Novi received three responses to our bid request, issued via BidNet, for a Nortel Telephone System Maintenance/Support Agreement. The maintenance contract with the recommended vendor (SunTel) consists of \$20,256 for 2 years (\$10,128 annually). The City also contracts for MAC services to the telephone system, which will be billed at \$84.15 per hour. We anticipate approximately \$15,000 annual for MAC charges. Alternate #1 (Testing of UPS) will be billed at \$84.15 per hour.
