SUBJECT: Approval to submit a Joint Application to the Oakland County Local Model Showcase Sustainability Partnership Grant Program with the City of Farmington Hills.

BACKGROUND INFORMATION: Oakland County as part of their OakGreen Initiative, has issued a request for proposal to award \$50,000 in contracted professional planning services and \$20,000 in County staff resources to geographically contiguous communities that have demonstrated a commitment to environmental sustainability and want to collaborate to create and adopt an inter-jurisdictional sustainability plan through the formation of a **Local Model Showcase Sustainability Partnership**. Both the City of Novi and Farmington Hills are committed to the development of such a partnership which would advance our existing efforts and identify opportunities for further community development, transportation enhancements, local energy and environmental sustainability as well as the redevelopment of existing corridors.

Both communities have already begun addressing sustainability related issues and have a proven track record of successfully implementing the requirements of the Energy Efficiency Conservation Block Grant Program as well as an established partnership to provide shared services for the 2010 Pathway Gap project. Novi and Farmington Hills were recently awarded the Oakland County Green Community Excellence Awards. Both Novi and Farmington Hills' Master Plan for Land Use have long held goals and recommendations for environmental sustainability within the community.

If awarded, Oakland County anticipates the planning process to begin October 1, 2010, and conclude June 30, 2012. The contractor that will provide planning services would be selected with input from the selected communities. A commitment of 150 staff-hours per community is required, however any additional financial resources are optional. Attached are letters from OLHSA as well as AKT Peerless offering their cooperation and support to our efforts.

RECOMMENDED ACTION: Approval to submit a Joint Application to the Oakland County Local Model Showcase Sustainability Partnership Grant Program with the City of Farmington Hills.

Approval to submit a Joint Application to the Oakland County Local Model Showcase Sustainability Partnership Grant Program with the City of Farmington Hills

WHEREAS, the City of Novi and the City of Farmington Hills have both been active proponents of energy and environmental sustainability and were recently awarded the Oakland County Green Community Excellence Award;

WHEREAS, both the City of Novi and Farmington Hills are committed to the development of a Local Model Showcase Sustainability Partnership which would integrate economic, community and environmental goals and identify needed efforts for advancing local sustainability through the development of an action plan that identifies synergistic opportunities amid community development, transportation, local energy and environmental sustainability and the redevelopment of existing corridors;

WHEREAS, the City's of Novi and Farmington Hills are committed to using this partnership to advance the Environmental Protection Agency's Livability Principals including: more transportation choices, promoting equitable and affordable housing, enhancing economic competitiveness, supporting redevelopment in existing communities, leveraging federal policies and investment, and promoting the value of our two communities and its neighborhoods;

WHEREAS, the City of Farmington Hills and Novi both have a proven track record of successfully implementing the requirements of the Energy Efficiency Conservation Block Grant Program and have an established partnership to provide shared services for the 2010 Pathway Gap project;

NOW THEREFORE BE IT RESOLVED, that the City of Novi hereby authorizes the submission of a joint application to the Local Model Showcase Sustainability Partnership Grant be submitted to Oakland County in partnership with the City of Farmington Hills.

As part of the County's OakGreen Initiative (www.oakgov.com/oakgreen), Oakland County Planning & Economic Development Services seeks to work with two or three geographically contiguous communities that have demonstrated a commitment to sustainability and want to take the next step by collaborating to create and adopt an inter-jurisdictional sustainability plan through the formation of a Local Model Showcase Sustainability Partnership. Such a partnership will integrate economic, community and environmental goals and identify and prioritize existing and needed efforts and needed efforts for advancing local sustainability through the development of an action plan. We anticipate the planning process to begin October 1st, 2010, and conclude June 30th, 2012.

The sustainability plan will follow guidelines set forth by ICLEI-USA in their Sustainability Toolkit including:

- 1. Conduct a Sustainability Assessment
- 2. Establish Sustainability Goals
- 3. Develop a Local Sustainability Plan
- 4. Implement Policies and Measures
- 5. Evaluate Progress and Report results

The goal of the sustainability plan is to inventory existing community efforts that support sustainability, identify gaps and opportunities, and prioritize actions. Special attention for synergistic efforts between the communities will be paid. The final product will integrate these components into a single joint planning document. The criteria the county shall use for selecting which communities work together to create a collaborative sustainability plan will include:

- 1. Identification of a primary contact person for each community
- 2. Commitment of chief elected and administrative official with intent for resolutions
- 3. Quality of Narrative
- 4. Commitment of staff resources
- 5. Commitment of financial resources
- 6. Commitment of community non-governmental partners

Oakland County will contribute \$50,000 in contracted professional planning services and \$20,000 in staff resources to this effort. The contractor that will provide planning services will be selected with input from the selected communities.

On behalf of AKT Peerless Environmental and Energy Services (AKT Peerless), I want to express our support for the joint application by the Cities of Farmington Hills and Novi to the Oakland County Local Model Showcase Sustainability Partnership Program. As a Principal and Co-founder of AKT Peerless and a 14 year resident of Novi, I have a vested interest in success of the region. The issue of sustainability is not unique to any one community and it is absolutely critical that partnerships span jurisdictional boundaries and work together to enhance communities.

AKT Peerless has been working with municipalities throughout Michigan for over 20 years. This work has included environmental, economic development and energy consulting. It has become very clear that local units of government must work together to integrate economic, community and environmental goals to enhance the vitality of their region. In order for Michigan to move forward, sustainability planning must be addressed.

Both Farmington Hills and Novi have made significant sustainability strides already.
