SUBJECT: Approval to award a one year contract with two annual renewal options to Sheila Nauseda for Hair Salon services at Meadowbrook Commons beginning September 28, 2011.

BACKGROUND INFORMATION:

Meadowbrook Commons includes a hair salon facility enabling hair salon services to be provided to residents of Meadowbrook Commons and participants of the Senior Center programs through a contractual agreement with a hair salon vendor.

The current vendor, Debra Bye's contract expires September 27, 2011. The City requested proposals from area vendors interested in providing hair salon services; three proposals were received. Vendors were asked to include a rent amount for the space they utilize at the center and a summary of the charges for salon services rendered (perms, haircuts, shampoo, color and various other services).

The evaluation team compared all three proposals and is familiar with two of the three most competitive vendors and recommends the contract be awarded to Sheila Nauseda.

Sheila Nauseda provided 10 months of salon services at Meadowbrook Commons as a sub-lessee during the past year during which time she has proven to be a responsible vendor and has a good relationship with older adults. Although Debra Bye proposed a higher rent of \$410 per month compared to the \$300 per month, Sheila Nauseda provides a higher value by providing services to seniors at a lower cost. The vendor will pay \$3,600 annual rent to Meadowbrook Commons (the budgeted revenue for this item is \$3,000). This service is provided no cost to the City of Novi or Meadowbrook Commons and enhances the services to the tenants of the facility.

The term of this lease will begin September 28, 2011 and is a one year contract with two (2) annual renewal options.

RECOMMENDED ACTION: Approval to award a one year contract with two annual renewal options to Sheila Nauseda for Hair Salon services at Meadowbrook Commons beginning September 28, 2011.
