BACKGROUND INFORMATION:

The City of Novi was awarded \$137,600 in federal funding through the Surface Transportation Program for safety improvements at the intersection of Meadowbrook Road and Nine Mile Road. The attached map shows the location of the project, which consists of the reconstruction and modernization of the existing traffic signals at the intersection to a box span configuration, the addition of pedestrian countdown signals, an addition of left turn arrows. The project will also include construction of improvements to sidewalk ramps on all four corners of the intersection for compliance with the Americans with Disability Act (ADA).

An internal review by staff during the design phase revealed the opportunity to add an optical priority control system (Opticom) to this signal allowing additional control of the traffic signal by emergency response personnel during an emergency. An additional design engineering fee in the amount of \$4,500 is recommended for award for the design of this system along with additional design fee to complete the revisions of the sidewalk ramps at the intersection for compliance with Americans with Disability Act requirements.


Although discussed in the motion sheet presented at the April 23, 2012 meeting, the award of the \$4,500 was inadvertently omitted from the total amount included on the motion sheet.

It is anticipated that MDOT will award the project in May 2012 with substantial completion of the project this construction season.
