#### **BACKGROUND INFORMATION:**

The City has made arrangements with its bank (currently Fifth Third) to automatically redeposit items that have not been honored by the financial institution with which the funds are being drawn. The City charges \$25 for return deposit items. The purpose of this resolution is to update the title of the prior resolution dated November 24, 1997 (see attached) to cover all returned deposit items, not just "non-sufficient funds" returned items. Therefore, the attached fee resolution is in effect after the second attempt to deposit. There is no change from the current policy and procedure in place.

BE IT FURTHER RESOLVED that the \$25.00 fee be in addition to any penalty assessed for late payment.
