The proposed six(6) sq. ft. sign is virtually invisible from the public right-of-way given the setback and the dense landscaping. This sign will replace the existing "entrance" letters and will create a more architecturally pleasing entryway into the building.

Hino Truck Office Building

41180 Bridge Street

The proposed seventy-five(75) sq. ft. wall sign will be the only identification for this building and will only be visible from the I-96 ramp to I-275. Considering the limited visibility due to the adjacent trees as well as the vehicle speed of the viewing public, this is an appropriate size sign for this location.

Robin, let me know if this is adequate.





Variance Request: One 70 square foot ground sign for the business located at 39550 Orchard Hill Place. Applicant is requesting one two-foot six-inch height variance and one thirty square foot area variance.

At the June 5, 2007 Regular Meeting of the Zoning Board of Appeals the following motion passed:
