**Participant Waiver, Release of Liability, and Code of Conduct Agreement** (Must be signed before participating in any event or activity)

#### Assumption of Risk

As a registered participant, or the parent/legal guardian of a registered participant, in the listed activity or event, I acknowledge and understand the inherent risks involved, which may include, but are not limited to, cuts, bruises, broken bones, and other injuries or losses. I voluntarily assume all risks of injury, damage to persons or property, or death resulting from my or my child's participation in this activity or event, as well as from the use of City of Novi facilities or services. I hereby release and discharge the City of Novi, its officers, agents, employees, volunteers, sponsors, and organizers from any and all liability for injury (including death), damages, or losses arising from negligence or gross negligence. Additionally, I agree to indemnify and hold harmless the City and its representatives from any liability resulting from my or my child's participation in the listed activity or event. This Participant Waiver, Release of Liability, and Code of Conduct Agreement shall be binding upon my heirs and dependents.

#### **Code of Conduct**

The City of Novi PRCS is committed to creating a safe and welcoming environment for all program participants. All participants are expected to treat others with courtesy and respect. Harassment, intimidation, vulgar or abusive language, and any behavior that is destructive, dangerous, or disruptive are strictly prohibited. Violations of this Code of Conduct may result in disciplinary action, including but not limited to warnings, removal from the program or premises, suspension of privileges, or involvement of law enforcement. Participants will receive written notification of any such action taken. PRCS reserves the right to use its sole discretion in determining the appropriate disciplinary actions for any violations, taking into account the nature and severity of the conduct to maintain a safe and respectful environment. Participants who witness or experience inappropriate conduct are encouraged to report it to PRCS staff immediately. To ensure the safety and well-being of all participants, PRCS may involve law enforcement if necessary. PRCS also reserves the right to amend this Code of Conduct at any time.

#### Online Classes/Remote Access to Events.

I understand that to ensure an atmosphere conducive to education, instructors and administrators may mute, screen, remove, or further ban participants for violations of the Code of Conduct.

### **Online Activities and Competitions**

The City of Novi is not responsible for third-party access to your identity, profile, or personal information in connection with any online activities, including competitions. It is the user's responsibility to protect their identity and personal information. The City does not monitor online competitions for language or conduct; it is the responsibility of the participant or their parent/guardian to monitor these activities. To maintain sportsmanship and skill competition, participants may be penalized for inappropriate behavior, including disqualification or forfeiture.

### Photo/Video Authorization

I authorize the City of Novi to use photos or video of myself and/or my minor child participating in a City-sponsored program or event for future marketing materials. Participants will only be named with their consent, or the consent of their parent/guardian if under 18 years of age. Event attendees must notify the photographer if they do not wish to be photographed.
