SUBJECT: Approval of resolution to permanently transfer Precincts 20 and 21 currently located at Deerfield Elementary to Oakpointe Church, 50200 W. 10 Mile effective immediately.

BACKGROUND INFORMATION:

Section 3.1 of the Charter states that the Council shall fix the location of the polling places.

In preparation for the 2015 elections, Council's approval is being sought to transfer the two precincts currently located at Deerfield Elementary to Oakpointe Church located at 50200 W. 10 Mile Road. Whenever possible, our goal is to locate a precinct in a non-profit facility where residents are not interminaling with students.

I toured the facility with Executive Pastor of Business and Operations, Daryl Rice, who later met with the Church Board. We have reached agreement with them to become a polling location beginning with the May 5, 2015 Election. Election law also requires that we notify all voters in Precincts 20 and 21 of the change in location.

In order to begin the process with the Secretary of State, proposed changes must be approved by City Council, submitted no later than March 1, 2015 to the State Bureau of Elections.

RESOLUTION APPROVING POLLING LOCATION CHANGE FROM DEERFIELD ELEMENTARY TO OAKPOINTE CHURCH FOR PRECINCTS 20 AND 21

WHEREAS, the City of Novi has 21 voting precincts and 15 polling locations, as established in 2008. Since that time, increases in population near the western boundary of Novi has created a need to relocate two precincts; and

WHEREAS, all planned precinct changes were granted by the local Election Commission and must be approved by the City Council per Charter Section 3.1;

WHEREAS, the rearrangement of precincts are governed under Michigan Election Law, MCL 168.657, and must be submitted to the Michigan Department of State by March 1, 2015; and


WHEREAS, this proposed change will eliminate the pedestrian traffic inside Deerfield Elementary School and parking congestion at the polling location, thus encouraging voter participation.

NOW, THEREFORE, BE IT RESOLVED, the Novi City Council approves the following voting precinct change:
