BACKGROUND INFORMATION:

Improvements to the Civic Center Main Parking Lot (south of the Civic Center) and Novi Way, along with the Police Department's east entrance drive were recommended by the Parking Lot Inventory and Maintenance Plan completed in January 2014. The work in the main parking lot and Novi Way will include crack repair and patching followed by a hotmixed-asphalt overlay of the entire parking lot and Novi Way. The pavement cross-section for Novi Way also includes a geotextile fabric separator beneath the asphalt overlay to decrease reflective cracking associated with higher traffic on the access road. Improvements to the Police Department's east Entrance will include repairs followed by a hot-mixed-asphalt overlay of the entire entrance. The Power Park Pathway Rehabilitation component includes full depth reconstruction and rehabilitation of selected pathway segments in Power Park with pathway widening and drainage upgrades to improve maintenance access for City staff. These projects have been combined because of their close proximity to each other to receive a lower bid based on economies of scale.

A total of five bids were received and opened on June 30, 2016 following a public bid solicitation period. The lowest responsive and responsible bidder is Cadillac Asphalt, LLC. Cadillac's bid is recommended as being in the best interest of the City as it is responsive (i.e., Cadillac Asphalt, LLC. has complied with all requirements of the bidding instructions), Cadillac is a responsible contractor that meets the qualifications specified in the bid

documents, and Cadillac submitted the second lowest price. (AECOM's award recommendation letter including the bid tabulation dated is attached). The lowest-priced bid submitted by Pavex Corp. was rejected due to failure to acknowledge the bid addendum and, more importantly, Pavex's failure to satisfactorily perform work required by contract with the City within the past three years. 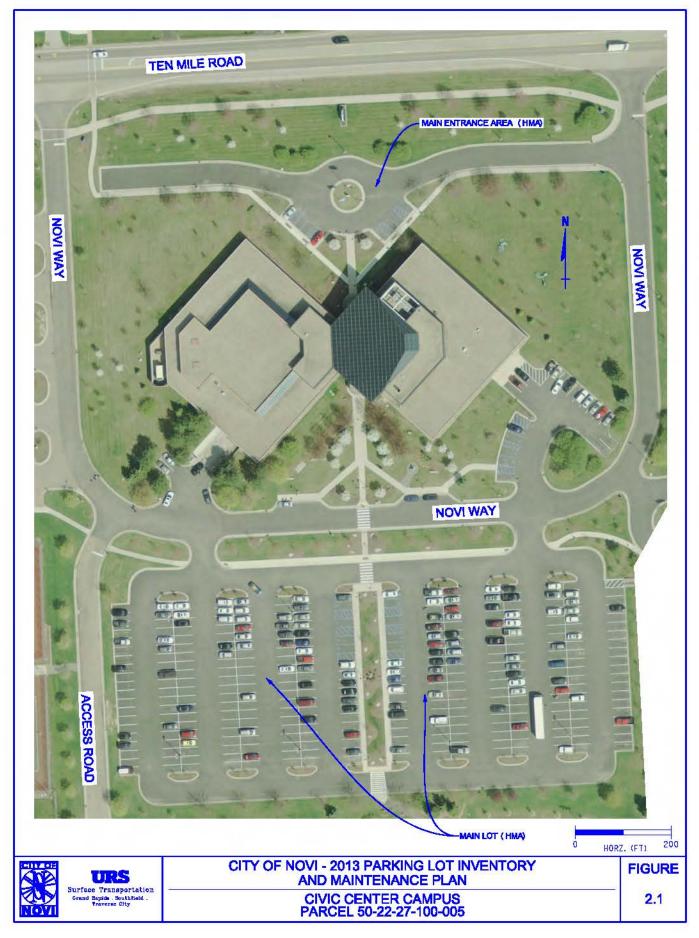

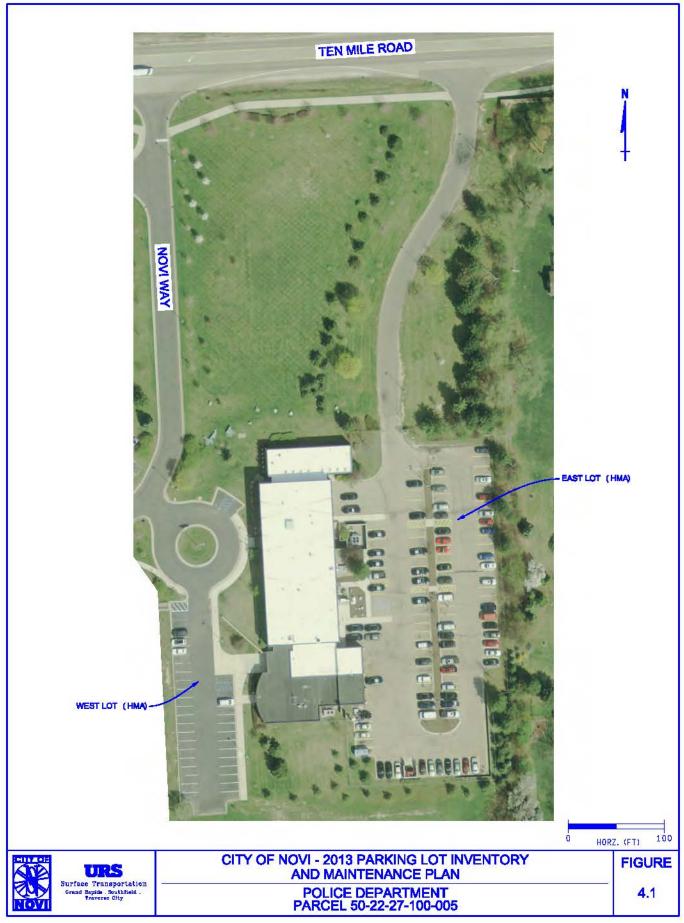

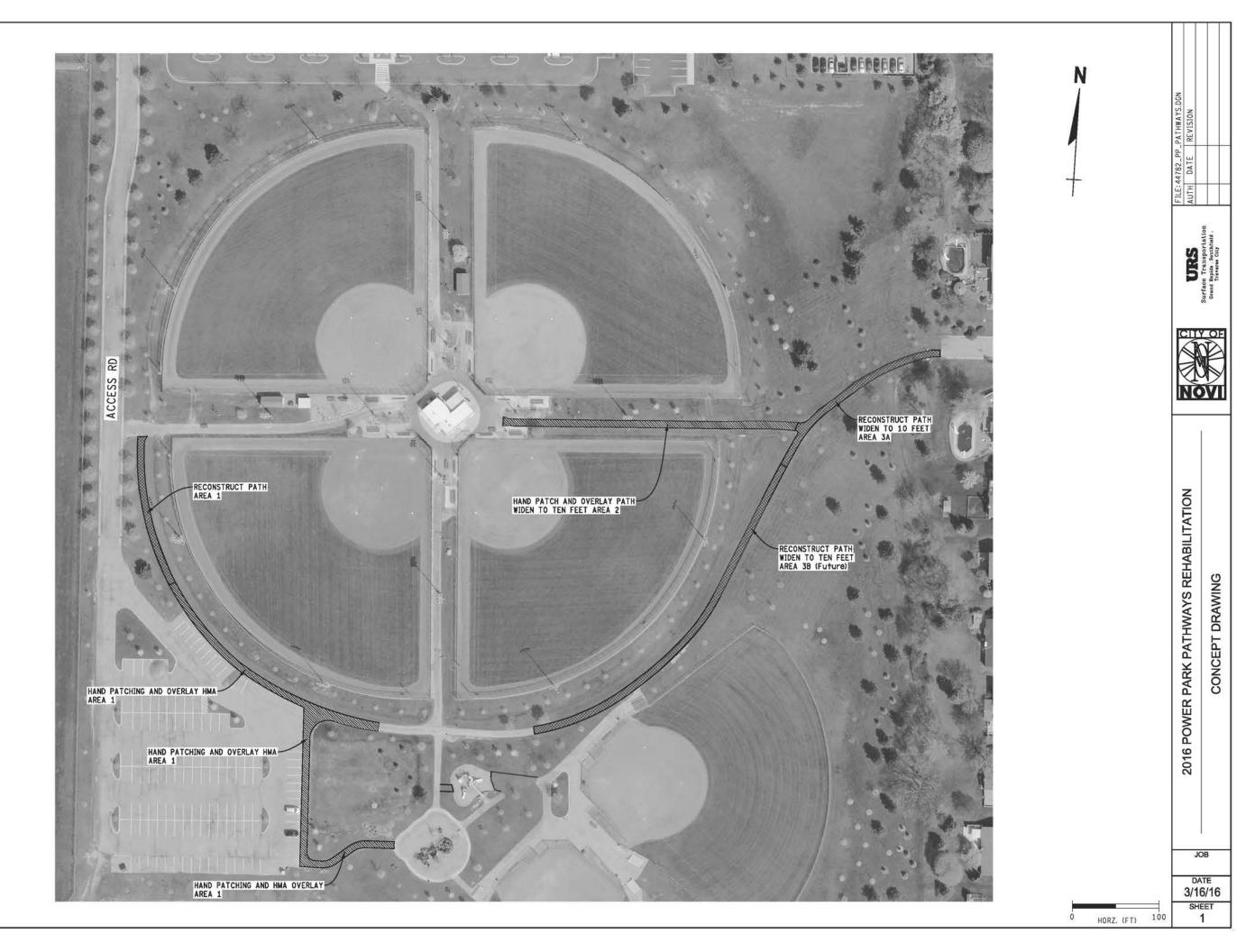
Construction of the project will begin this summer (after the major softball tournament to be held at Power Park in late July) and be completed this fall. The parking lot will be constructed in two phases to minimize the impact on those visiting the Civic Center. The construction engineering award is proposed for consideration elsewhere on this agenda.

Attached is the Bid Tabulation for the above referenced project. Five bids were received and opened. The accepted bid is \$39,218.80 over the latest Engineer's Estimate.

Pavex Corporation, the low bidder, was disqualified because they did not acknowledge receipt of Addendum 1 and they have failed to complete work required per contract with the City within the past three years.

Cadillac Asphalt, LLC, the next low bidder, has successfully completed similar projects for the Wayne County Airport Authority, Camelot Village MHP, and DTE Monroe. We also contacted references and they have performed satisfactorily on these projects. The bonding company listed in the Statement of Qualifications (Western Surety Company, Richmond Agency is the agent) has an AM Best rating that exceeds the minimum requirements.

We recommend award of the contract to Cadillac Asphalt, LLC for the Bid Amount, excluding crew day costs, of \$668,539.40.
