BACKGROUND INFORMATION:

Engineering staff received a complaint from a resident on New Court, located east of East Lake Drive and south of 14 Mile Road regarding parking on both sides of the streets restricting the flow of traffic. The westernmost portion of New Court was recently acquired and paved by the City as part of the Neighborhood Connector Pathway project between East Lake Drive and Novi Road. The paved portion of New Court is only 22-feet wide. If parking is permitted on both sides of New Court (as shown in the attached photo), there is not enough space to allow larger vehicles, like a fire truck, to pass through. Therefore, staff recommends the installation of no parking signs along the south side of New Court (along the frontage of the property owned by the City).


Traffic control orders are required by the Uniform Traffic Code to enforce traffic control signs that have been installed on public streets. Therefore, staff has reviewed the installation of the traffic control sign and has prepared the attached traffic control order for approval by City Council.

The traffic control signs will be scheduled for installation in the coming weeks through the DPS Field Operations Division.
