Min Kyu Kim, applicant, said he was working with a partner all week and found a grill company that will provide the correct documentation, and the partner has verbally agreed on the new company. He said they are called Samsung Grills. He said the ducts will be underground still. Member Staudt asked if they would be starting on time. Mr. Kim said they would start late, but as soon as possible. Member Staudt said congratulations on bringing the business into the Sakura development. Mr. Kim said he is very excited to provide this new Korean Steakhouse for the Novi community. He said a lot of people his age has been moving into Novi. He said this centralized community

development will be very good for the community. Member Staudt said ten years ago, the applicant probably wouldn't have been given a license because new business wasn't their focus back then. He said the focus was existing businesses wanting to expand, but that way of thinking has changed over the years. He said he looks forward to visiting the restaurant and having a beverage.

Member Thomas said in reviewing the application she thought the area is new and developing and is a great place to have that available where it wasn't before. She said the idea is to have an open space. She said it very much fits what they are looking for in applications for liquor licenses, and she wholeheartedly supports it.

Mayor Pro Tem Casey said she is excited to see a development or opportunity such as this one going into Sakura. She said she thinks it is going to really help bring more attention to that area, and what is going in is something they have not seen before. She said thank you for investing in Novi. She said they have her support on this.

She said she was researching the area on the things around the location, and that this will be something new and different. She said she looks forward to what they bring to the table.

Mayor Pro Tem Casey said she would like to welcome them to the city. She said she thinks it is wonderful that they are not just bringing an Indian restaurant to Novi, but they are within walking distance for a lot of people. She said she appreciates that they have chosen that specific location. She said she looks forward to supporting this item.
