SUBJECT: Approval to award design engineering services to Spalding DeDecker for new pickleball courts at Wildlife Woods Park, in the amount of \$18,400.

BACKGROUND INFORMATION: The sport of pickleball has continuously grown in popularity during the past several years, especially among the older adult population. With the older adult population increasing and multiple local pickleball groups contacting the City in search of courts to use, creating dedicated pickleball courts is the preferred response to this need rather than markings on existing tennis courts.

PRCS has been seeking an appropriate location to install pickleball courts in Novi. Factors in consideration include noise generated by the courts, accessibility to the courts and available space for construction. With a new access drive from Wixom Road, new parking lot adjacent to the park shelter and proximity to the ITC Trail, Wildlife Woods Park is an ideal location for construction. The courts would also provide an additional revenue stream through leagues and tournaments.

The design proposal includes four (4) pickleball courts adjacent to the existing pavilion, with an ADA compliant walkway and benches. Spalding DeDecker's (SDA) engineering fees are based on the fixed fee schedule established in the Agreement for Professional Engineering Services for Public Projects. The design fees for this project will be \$18,400, 11% of the estimated construction cost of \$167,320. Spalding DeDecker's design proposal is enclosed and includes the project scope and schedule.

The Novi Parks Foundation is contributing \$100,000 towards the project, which will be included on the 2nd Quarter Budget Amendment to Council. These funds will offset

the remaining \$100,000 needed. Design of this project would begin following award with construction estimated to begin in May 2020.

RECOMMENDED ACTION: Approval to award design engineering services to Spalding DeDecker for new pickleball courts at Wildlife Woods Park, in the amount of \$18,400.

Spalding DeDecker (SD) is very pleased to have this opportunity to present this proposal to provide engineering services for the design of 4 pickle ball courts at Wildlife Woods Park. The new courts will be added adjacent to the existing pavilion and will include an ADA walkway, benches and allow for future courts, if needed.

SCOPE OF WORK

Spalding DeDecker will generate detailed site engineering plans to be used for permitting, bidding and construction of the pickle ball courts.

Our scope of services will include the following tasks:

- Meet with City staff to finalize detailed scope of the project.
- Prepare a topographic survey of the area.
- Prepare preliminary plans for review.
- Prepare engineering drawings and specifications for permitting, bidding and construction. The plan sets will include at a minimum:
 - o Cover Sheet
 - o Notes and Details
 - o Topographic Survey/Demo Plan
 - o Site Plan
 - o Site Grading Plan/Stormwater Control
 - o City Standard Details, as needed.
- Assist with the bidding process.
- Conduct a pre-construction meeting
- Provide construction engineering services
- Provide construction inspection

Construction Cost Estimate and Proposed Fees

Based on our pre-qualification status with the City, engineering design fees are based on a percentage of the pre-design construction cost estimate. The fee percentage used depends on the type of services to be



provided based on the proposed work. However, the nature of this project does not correlate to the types of services pre-established in the fee table. The fees below are based on estimated hours to complete the work.
