## 1. Redevelopment Ready Communities - Elizabeth King and Dominic Romano

Elizabeth King said she was the Redevelopment Ready Planner for Region 10 at Michigan Economic Development Corporation. She introduced Dominic Romano of the Community Assistance Team. Ms. King thanked the Mayor, City Council, and the hard working City staff, specifically Charles Boulard for all the hard work the City has done. On behalf of the Michigan Economic Development Corporation (MEDC) she congratulated the City on receiving RRC Certification. She stated that there are over 270 communities involved in the RRC Program; the City of Novi is the 35th to receive the RRC Certification. The City of Novi joins a short list of communities that have achieved the list and are actively planning, zoning and marketing their city to achieve the development vision outlined by their community. She said that Novi undertook major projects to achieve the RRC Certification. Including, but not limited to, a 2016 Master Plan update, the creation of a Corridor Improvement Authority TIF Plan in 2018, ongoing zoning ordinance updates and a streamlined development review process. She explained that all the resources and materials are online. The City has also updated the Boards and Commissions application with designed skill sets and information on the appointment process. The City continues to implement strong economic development and marketing strategies and they proactively promote priority redevelopment site. She said they saw many on their tour. RRC Certification is a signal to the community and development world that Novi is open for business and has a streamlined and organized development review process. It also signals that Novi is striving to create the type of place that will continue to attract talented residents and businesses for years to come. RRC Certification is an official status is an ongoing process with ongoing benefits. Benefits of the RRC Certification include continued technical assistance funding eligibility for projects related to RRC Certification. Site specific predevelopment assistance funding, access to their redevelopment services team for the marketing promotion of sites, prioritization for project specific gap financing through the Michigan Economic Development Corporation (MEDC) through the community development tools, access to free training opportunities, community promotions and more. In closing she stated that they were excited to continue to develop a strong partnership with the City of Novi and stakeholders to support and implement the community's vision for development and redevelopment.

# MATTERS FOR COUNCIL ACTION

# 1. Consideration of approval to appropriate \$100,000 toward consultant services for the City of Novi Recreation Center Committee and amend the budget.

Mayor Gatt said when he saw this on agenda he was taken aback, but after talking with people, it made perfect sense. He stated that the Recreation Center is going to be, if it comes to fruition, one of the jewels and highlights of the City of Novi. He said they want to do it right. To begin with, we need a survey of the citizens to find out what they want, if they want this at all. He said he would support this.

Mayor Pro Tem Staudt said as Chairman of the Committee they asked for an allocation of funds because there are multiple things that may or may not be done. We are going to do an extensive survey and get a good indication on what this community is looking for. They want a good consultant to lead us in the right direction. They may or may not spend all of \$100,000, we may spend more. It depends on how far the project goes. He stated that our goal is an August election if this is what the community wants.

# Approval to appropriate \$100,000 toward consultant services for the City of Novi Recreation Center Committee and amend the budget.

Member Mutch asked City Manager Auger if any contract approved under \$15,000 can be done administratively. Mr. Auger said that was correct. Member Mutch asked if there was any indication that it would be done administratively or should all of these come to City Council. Mr. Auger said they started the process with the survey information moving quickly if we are going to get this August guideline. He said our estimate will be \$15,000 to \$20,000 so it would come back to Council if it's over \$15,000. He stated any consultants that we don't have on staff would go through the Consultant Review Committee and then back to City Council. Member Mutch said he was supporting this because there will be required additional resources to fund this

information gathering and the public input process to bring forward a proposal that meets needs of community. He hoped City Administration shares back with City Council anything that doesn't normally go before them. He said these are unusual.

Member Breen stated that in the first public meeting transparency was discussed and a separate website will be set up so that they can see documents and review minutes. She wondered where we were in that process. City Manager Auger said that both the Roads Committee and Recreation Center already have space on the website where people will be able to see agendas and minutes. He mentioned the Recreation Center has links to Parks, Recreation, and Cultural Services plan and the interactive map. Member Breen said she supported this. She said she had sticker shock, but we need to do this right, we need to get public input, and where the needs aren't being met so that we know what to move forward with. Other cities have spent more and others less. She was excited to see what comes about.
