SUBJECT: Approval of a cost participation agreement with Ascension Providence Hospital for the construction of a sidewalk connection between the ITC Trail, Wildlife Woods Park, and Ascension Providence Hospital, with Ascension Providence Hospital's estimated responsibility in the amount of \$26,068.50.


BACKGROUND INFORMATION:

In 2020, the Southeast Michigan Council of Governments (SEMCOG) selected the City's ITC Trail to Wildlife Woods Park Pathway Connection for funding through the Michigan Department of Transportation's (MDOT's) Transportation Alternatives Program (TAP). On September 13, 2021, City Council adopted a resolution authorizing approval of a cost share agreement with MDOT for the construction of a pathway connection between the existing ITC Trail and Wildlife Woods Park. The project is split into two parts:

- Part A: Pathway connection from Wildlife Woods Park to the ITC Trail
- Part B: Pathway connection from the ITC Trail to Ascension Providence Hospital property line (not eligible for grant funds)

Ascension Providence Hospital approached the City last year about the pathway connection because Ascension had been planning to expand its internal pathway network, and a connection to the ITC Trail and Wildlife Woods Park from Ascension's property would be beneficial to Ascension's visitors. City staff worked with Ascension staff and the City Attorney to draft a cost participation agreement where Ascension agrees to pay the City for construction of Part B, \$26,068.50, which will connect to Ascension's planned trail network. The City Attorney favorably reviewed the cost participation agreement between the City and Ascension Providence Hospital (Beth Saarela, February 24, 2022). Construction of the pathway connections is expected to begin in April 2022.

RECOMMENDED ACTION: Approval of a cost participation agreement with Ascension Providence Hospital for the construction of a sidewalk connection between the ITC Trail, Wildlife Woods Park, and Ascension Providence Hospital, with Ascension Providence Hospital's estimated responsibility in the amount of \$26,068.50.



Dear Ms. Runkel:

We have received and reviewed the enclosed final executed Cost Participation Agreement between the City and Ascension Providence Hospital for the purpose of constructing an additional segment of sidewalk to allow a connection between the ITC Trail and Wildlife Woods Park for the public to access over and through the ITC Corridor, terminating at Ascension's Property. The sidewalk connection will provide benefits to Ascension's visitors by providing direct access to the ITC Trail and Wildlife Woods Park from Ascension's Property over the ITC Corridor to Wildlife Woods Park once Ascension completes its internal trail network. The City included this additional segment to its project at Ascension's request subject to Ascension's payment of construction costs for this additional segment.

COST PARTICIPATION AGREEMENT SIDEWALK CONSTRUCTION

ITC TRAIL CONNECTION TO WILDLIFE WOODS PARK ASCENSION PROVIDENCE PROPERTY City of Novi

This Agreement, made and entered into this _____ day of _____, 2022, by and between ASCENSION PROVIDENCE HOSPITAL, a Michigan non-profit corporation, whose address is 47601 Grand River Ave., Novi, Michigan 48374 (Owner) and the City of Novi, a Michigan municipal corporation, whose address is 48375 Ten Mile, Novi, 48375 (City), provides as follows:

WHEREAS, the City is currently constructing a sidewalk connection project over various parcels of Property in the City of Novi for the purpose of making a sidewalk connection between the existing ITC Trail and Wildlife Woods Park (the "Project"). Construction of an additional segment of sidewalk would allow a connection between the ITC Trail and Wildlife Woods Park for the public to access over and through the ITC Corridor, terminating at the Owner's Property, as shown in the attached and incorporated Exhibit A (the "Ascension Segment"). The sidewalk connection would provide benefits to the Owner's visitors by providing direct access to the ITC Trail and Wildlife Woods Park from Owner's Property over the ITC Corridor to Wildlife Woods Park once the Owner completes its planned internal trail network. The City is willing to include the Ascension Segment to allow this additional connection, as a change order to its Project subject to the payment of construction costs for the Ascension Segment by Owner; and

WHEREAS, the City has obtained an easement over the ITC Corridor in the location of the Ascension Segment;

WHEREAS, the estimated total cost of constructing the Ascension Segment is \$26,068.50 and

WHEREAS, the parties hereto have reached a mutual understanding regarding the cost sharing of the Ascension Segment and wish to commit that understanding to writing in this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein and in conformity with applicable law, it is hereby agreed between the City and Owner that:

- The City shall undertake and complete the construction of the Ascension Segment, as above described in the attached and incorporated Exhibit A in connection with the Project.
- Upon completion of the Ascension Segment, the City shall own the Ascension Segment and shall be responsible for on-going maintenance, repair, and replacement of the Ascension Segment at its own expense.
- 3. The City shall be responsible for the cost of maintaining the easement per its agreement with ITC.
- 4. In addition to payment for the Ascension Segment, Owner agrees to permit public access over its internal trail system and has agreed to grant a license to the City confirming public access over its internal trails. The license agreement shall be provided prior to the Final Stamping Set approval for the Owner's internal trail connecting to the Ascension Segment.
- 5. Any cost overages with respect to construction of the Ascension Segment shall be paid by Owner.

- Upon execution of this Agreement, the City shall submit an invoice to the Owner for the total amount due (being 100% of the Owner's share of the estimated total cost of the Ascension Segment).
 - a. The invoices shall be sent to:

7. Upon receipt of said invoice, the Owner shall pay to the City the full amount thereof, within thirty (30) days of such receipt. IN WITNESS WHEREOF, the parties hereto have executed this Agreement the day and date first written above.


