BACKGROUND INFORMATION:


Over the past year, the City has been collaborating with the Novi Community School District (NCSD) and City Engineering Consultant OHM Advisors to solicit funding from the Michigan Safe Routes to School (SRTS) grant program. SRTS is a federally funded program designed to encourage and enable children in grades K-8 to walk and bicycle to school, including those children with disabilities.

City staff identified seven (7) school campuses in the NCSD as the candidates for funding: Deerfield Elementary, Parkview Elementary, Novi Woods Elementary, Novi Meadows Elementary, Orchard Hills Elementary, Village Oaks Elementary and Novi Middle School. Each school completed a parent and student survey about the current challenges of walking to school. Following the surveys, a multi-agency, district-wide walking audit was completed, public meetings were held, and a presentation was given to City Council at their regular meeting on April 15, 2019. At City Council's Regular Meeting held on June 3, 2019, three scopes of work were presented. Council Members voted and unanimously approved scope of work Option #2 which has the most impact in neighborhoods but maximized grant dollars.

As part of the SRTS application process, once a final plan of action is accepted and approved by the municipality, the final plan of action cannot be altered. Given this is a federally funded program administered by MDOT, the City (ACT 51 Agency) is required to adopt a resolution for the utilization funding in the amount of \$1,400,000 (total possible funding) to construct sidewalks, crosswalks, and pedestrian signals. The City will also be responsible for any construction costs above the grant total of \$1,400,000. A separate cost participation agreement with the NCSD will be required if the City is awarded the grant.

The City Attorney has reviewed the resolution and sees no legal impediment (Beth Saarela, June 24, 2019).

Re: Revised Memorandum of Understanding – Safe Routes to School Program

Dear Mr. Herczeg:

On January 28, 2019, City Council approved a Memorandum of Understanding for the Safe Routes to School Program (SRTS) between the City and the Novi Community School District. The Memorandum of Understanding is for the purpose of memorializing the City and School District's agreement to cooperate in the participation of the SRTS Program, which is a federally-funded program administered by MDOT to provide grants to construct or improve routes to school to make walking and bicycling to school safer. The Memorandum was provided for the purpose of apportioning costs for participating in the SRTS Program between the City and the Novi Community School District.

MDOT has requested that the City provide a Resolution to Adopt and Utilize Public Act 51 Funding for Safe Routes to School. The purpose of the Resolution is to: (1) authorize a specific employee, official, or agent to, request SRTS funding, act as the applicant road agency's agent during project development, and sign a project agreement upon receipt of a funding award; (2) attest to existence of, and commit to, the funds necessary to carry out the project (engineering for design and construction, permit fees, administration costs, etc.); and (3) commit to owning, operating and funding/implementing a maintenance plan/program over the design life of the facility constructed with SRTS funding. The enclosed Resolution is satisfactory for this purpose.

WHEREAS, the Safe Routes to School program (SRTS) is a federally funded program administered by the Michigan Department of Transportation (MDOT); and

WHEREAS, the City of Novi for Oakland County, Michigan and the Novi Community School District have applied for SRTS funding. If awarded SRTS funds, the City will construct certain infrastructure projects throughout the City, including sidewalks, crosswalks and the installation of pedestrian signals to enable and encourage children to bicycle and walk safely to and from school; and

WHEREAS, the City of Novi for Oakland County, Michigan will work with the Novi Community School District to complete the project and designates Jeffrey Herczeg, Public Works Director, to act as agent on its behalf; and

WHEREAS, the maximum awarded SRTS grant amount is \$1,400,000 with no required local match; and

WHEREAS, the City of Novi agrees that administrative, coordination, permit fees, preliminary engineering, right-of-way acquisition and construction engineering services related to the implementation of the SRTS project will be paid pursuant to the Memorandum of Understanding between the City of Novi and the Novi Community School District, dated February 27, 2019, attached and incorporated as Exhibit A; and

WHEREAS, the City of Novi and Novi Community School District commit to owning, operating and implementing a maintenance program over the design life of the facilities constructed with SRTS funding; and

NOW, THEREFORE, BE IT RESOLVED, that the City of Novi for Oakland County, Michigan and the Novi Community School District will utilize SRTS funds to construct sidewalks, crosswalks and pedestrian signals upon approval of staff.

BE IT FURTHER RESOLVED, this resolution is made a part of the minutes of the City of Novi meeting on ______, 2019.

RECITALS

WHEREAS, the City has requested that NCSD cooperate with the City in implementing a Safe Routes to School program to serve the residents of the City, especially those children attending NCSD elementary and middle schools;

WHEREAS, pursuant to Section 11a(3) and (4) of the Revised School Code, MCL 380.1 *et seq.*, a general powers school district has the authority to exercise a power incidental or appropriate to the performance of any function related to the operation of the school district in the interests of public elementary and secondary education in the school district and to enter into agreements or cooperative arrangements with other entities, public or private, or join organizations as part of performing the functions of the school district; and

WHEREAS, pursuant to the Urban Cooperation Act of 1967, MCL 124.501 *et seq.*, and the Intergovernmental Contracts between Municipal Corporations Act, 1951 PA 35, MCL 124.1, *et seq.*, each Party to this Agreement may enter into this Agreement in order to establish the terms and conditions upon which they cooperatively perform and carry out a service that they each may perform separately.

NOW, THEREFORE, in consideration of the mutual promises herein contained, the Parties hereto agree as follows:

Purpose of MOU: The purpose of the MOU and any addendums attached is to detail a cooperative working relationship between the parties stated above, committed by mutual agreement to construct select sidewalks and pathways as part of the Safe Routes to School Grant Project. The project includes construction of select sidewalks, pathways, and ramps both on campus and nearby each of the K-8 schools within the Novi Community School District (NCSD) proposed to be operating as such for the 2020-2021 school year. Safe Routes to School (SRTS) is a federally funded program administered by the Michigan Department of Transportation (MDOT). The program was developed to enable and encourage children in grades K-8, including those with disabilities, to walk and bicycle to school; to make bicycling and walking to school a safer and more appealing transportation choice, thereby encouraging a healthy and active lifestyle from an early age; and to facilitate the planning, development, and implementation of projects

and activities that will improve safety and reduce traffic, fuel consumption, and air pollution in the vicinity of elementary schools. The parties set forth their understandings in this MOU on some of the major points of the contemplated transactions. This MOU is a preliminary document and creates no right and imposes no obligation on any Party. However, the Parties agree to work cooperatively, expeditiously and efficiently to attempt to complete the transaction, using this MOU as a guide.

Key Roles and Responsibilities: The key roles and responsibilities of this SRTS project are as follows:

The City, in collaboration with NCSD, agrees to apply for a Safe Routes to School (SRTS) grant application in the 2019 grant cycle for infrastructure related projects. City agrees to bear consultant costs associated with preparation of the grant application on City and NCSD's behalf. MDOT has historically provided the required 20% local match for the grant. Should MDOT not pay this match, City and NCSD will provide the local match for their respective portions of the project for any grant awarded to City and/or NCSD. City and NCSD's potential liability should MDOT not provide the local match would be 99% and 1% respectively. The estimated maximum out of pocket dollar amount projected at this time if the 20% local match is not paid for by MDOT for the City and NCSD would be \$276,500 and \$3,500 respectively. In addition, City and NCSD agree to pay for non-participating matching items including design and construction administration which are estimated at \$237,000 and \$2,400 respectively.

Up to an additional \$8,000 non-infrastructure grant is available for each of the NCSD elementary and middle school campuses. This grant can be used to help fund walking programs, purchase safety equipment, and provide walking and biking education to the students. These components will be included in the application as well.

City will maintain the proposed off campus improvements and NCSD will maintain proposed on campus improvements.

Liability: Each Party to this MOU shall be responsible for any claims arising out of the acts and/or omissions of their respective employees, contractors, representatives and agents during the performance of this MOU, as provided by law.

<u>Reservation of Rights</u>: This MOU does not and is not intended to impair, divest, delegate, or contravene any constitutional, statutory, and/or other legal right, privilege, power, obligation, duty, or immunity of the Parties.

Government Function: The work and activities performed pursuant to this MOU are governmental functions. It is the intention of the Parties hereto that this MOU shall not be construed to waive the defense of governmental immunity held by the City and NCSD.

Duration of MOU: The term of this MOU commences upon signature by both of the above listed Parties and expires upon the Project completion date. Either Party may terminate this MOU at any time upon thirty (30) days written notice to the other Party and in which event this MOU shall be automatically terminated.

<u>Compliance with Laws</u>: Each Party shall comply with all federal, state, and local statutes, ordinances, regulations, administrative rules, and requirements applicable to its activities performed under this MOU.

Severability: If a court of competent jurisdiction finds a term or condition of this MOU to be illegal or invalid, then the term or condition shall be deemed severed from this MOU. All other terms, conditions, and provisions of this MOU shall remain in full force.

Modification: Any modifications, amendments, recessions, waivers, or releases to this MOU must be in writing and agreed to by both Parties.

Entire Agreement: This MOU represents the entire agreement and understanding between the Parties. This MOU supersedes all other oral or written agreements and memorandums between the Parties regarding this subject matter. IN WITNESS WHEREOF, CITY OF NOVI and NOVI COMMUNITY SCHOOL DISTRICT have caused this Memorandum of Understanding to be signed on the dates indicated below.


Proposed Infrastructure Improvements

(4) Remove and replace existing damaged pavement and widen the paved area for the turn south into the school (for increased visibility and more turning room for users with bicycles and wheelchairs)




