A Letter from our WMHA President

Hello,



I hope this newsletter finds you and your family well as we move into spring. It's wonderful to see all the activity around Whispering Meadows as the warmer weather enters.

As a follow up to our recent Zoom call, I wanted to provide an update on where we are regarding our CCRs rewrite. A little background information for those who may be seeing this for the first time. The Board asked our Whispering Meadows counsel who specializes in HOAs to review language in the 2010 CCRs. We were specifically questioning enforcement of the CCRs (when several homes were in violation of CCRs) and articles which contained vague language. From that work, we discovered the 2010 CCRs were not validated in the manner outlined by our governing 1977 CCRs. Here is what the Board has done and is doing to address this.

- HOA counsel drafted The Affidavit of Facts and submitted to Oakland County.
- Board announces CCRs updates at 2021 Annual Meeting in person and streaming via Facebook.
- Summer 2021 property survey done on WM. All subdivisions (1-4) & Common Areas identified.
- Proposed CCRs drafted by HOA attorney & reviewed by Board with questions & answers.
- Board communicates proposed CCRs updates to membership in March, June, and December 2021 newsletters.
- January 25, 2022 proposed 2022 CCRs documents (3) mailed to members for review/information.
- February 16, 2022 proposed 2022 CCRs Zoom meeting held for memberships' questions, comments & concerns.
- From Zoom meeting a committee from larger membership was formed to work on clarifying language to articles based on all membership feedback provided to date. Work will also include cross referencing 1977 & 2010 CCRs to proposed 2022 document.

Next Steps

 Members encouraged to continue to provide proposed 2022 CCRs feedback to Board via Board email (wmhaboard@gmail.com), emails will be shared with Committee without names. Where appropriate, please include article and section numbers. Deadline for feedback April 16, 2022.

- Committee presentation to Board followed by Board review with questions, answers, and possible edits.
- Board communication to membership regarding 2nd proposed 2022 CCRs.
- Special membership meeting(s)to discuss 2nd proposed 2022 CCRs with further edits, if necessary.
- Establish and communicate secure voting procedures.
- Hold vote. 51% of all owners in good standing to ratify.

The Board understands and shares the concern members have provided regarding the financial impact of this project. In making our decision, consideration was given to immediate need, total membership impact, and budget surplus (result from collection of delinquent dues and Covid impact). Our goal is to spread the costs for this project over two budget years to reduce the impact on the Association. Board members will be available for conversations on Food Truck Tuesdays when their schedules permit. If you would like an email copy of the 1977 CCRs and By-Laws, please email the Board.

2022 dues invoices were mailed out on February 1st with a March 1st due date. 280 out of 338 homeowners (82.8%) have paid their 2022 dues. The second dues reminder will be mailed out on April 15th. We have 7 residents who have one or two years in back dues. If there is anything, I can do to make your experience here more enjoyable, please let me know.

In addition to going over yearly business, we will be voting on **two open board seats**. Per our bylaws Article V, section 2: *Election to the Board of Directors shall be by secret written ballot. At such election the members of their proxies may cast, in respect to each vacancy, as many votes as they are entitled to exercise under the provisions of the Declaration. The persons receiving the largest number of votes shall be elected. Cumulative voting is not permitted.* Per Article III, section 6: *At all meetings of members, each member may vote in person or by proxy. All proxies shall be in writing and filed with the secretary. Every proxy shall be revocable and shall automatically cease upon conveyance by the member of his(/her) Lot. Our CCRs state one vote for each lot owned and member in good standing (dues paid).* Please bring photo ID. If you are choosing to vote by Proxy (another member or Board Secretary voting on your behalf) send your request to our secretary, Nicole O'Neill, at the Board's email (wmhaboard@gmail.com). She will email you a form for the proxy process.

We will continue to receive applications from candidates until April 1st. If interested, please email the Board. Include a paragraph on what positive attributes you can bring to our association, your address and contact information. Nominations may also be made from the floor. We would verify the candidate(s) member status and ask the candidates to say a few words on his/her behalf. We have received one submitted candidate: Byron Muonio (40505 Mill Rd Ct E) and Matt Hannah (21835 Sunflower Rd), current Board member and the CCR chair, would like to run again.

FOOD TRUCK TUESDAYS


