SUBJECT: Approval of an Agreement for Direct/Temporary Connection to Sanitary Sewer and Water Main allowing 24561 Glenda Ave. (50-22-22-301-035) to connect to the City's public sanitary sewer system on Taft Road.

SUBMITTING DEPARTMENT: Department of Public Works, Water and Sewer Division

BACKGROUND INFORMATION:

A residential property owner contacted staff to inquire providing sanitary sewer and water service to 24561 Glenda (see map). Sanitary sewer and water do not exist along Glenda Avenue. However, the owner of this parcel has acquired an easement over the parcel to the north and to the west as necessary to allow private lead connections to the water and sewer mains along the east side of Taft Road.

This connection would be considered temporary and therefore requires the enclosed Agreement for Direct/Temporary Connection to Sanitary Sewer. The Agreement gives the City the right to require the parcel to abandon the temporary connection and reconnect to a sanitary sewer or water should a main be installed along Glenda Avenue in the future. The Agreement also stipulates the parcel shall be included in any future special assessment should a special assessment be established to fund the construction of a sanitary sewer benefitting this parcel. The City Attorney reviewed the attached documentation and found no legal impediment to entering the agreement (Beth Saarela, March 18, 2022).

RECOMMENDED ACTION: Approval of an Agreement for Direct/Temporary Connection to Sanitary Sewer and Water Main allowing 24561 Glenda Ave. (50-22-22-301-035) to connect to the City's public sanitary sewer system on Taft Road.

AGREEMENT FOR DIRECT/TEMPORARY CONNECTION TO SANITARY SEWER AND WATER MAIN

THIS AGREEMENT is made this <u>14</u> day of <u>March</u>, 2032 by and between the City of Novi, a Michigan municipal corporation, whose address is 45175 Ten Mile, Novi, Michigan 48375 ("City"), and Anthony and Laura Paulk, husband and wife, whose address is 24561 Glenda Ave., Michigan 48375 ("Owner")

RECITATIONS:

WHEREAS, the OWNER owns certain real property located within the City of Novi, Oakland County, Michigan, described as follows:

> 24561 Glenda Ave., Novi, MI 48375 Parcel ID # 50-22-22-301-035

T1N, R8E, SEC 22 SALLOW'S WALNUT HILL NO. 2 SUB LOT 73 (the "Property")

- WHEREAS, public lateral sanitary sewers and water mains of the City of Novi are not as yet available to serve said property, and
- WHEREAS, lateral sanitary sewers and water mains may eventually be constructed to serve the individual properties located in the subdivision and/or area in which the Property is located, which lateral sewers and water mains may be financed by the levying of a special assessment or connection charge against the properties especially benefited, and
- WHEREAS, the OWNER wishes to be served by sanitary sewer and water facilities at this time in order to develop the Property, and
- WHEREAS, it is possible to provide sanitary sewer and water services to the Property by means of a direct/temporary connection to the sanitary sewer and water main by providing private connections through 24676 Taft Rd, Novi, Michigan 48375 and parcel 22-22-301-034 in Novi, MI 48375 to the sanitary sewer and water main located along the east side of Taft Road (the "Sanitary Sewer").

- WHEREAS, the CITY is willing to permit a direct/temporary connection to the sanitary sewer and water main in accordance with the following conditions,
- NOW, THEREFORE, in consideration of the CITY providing sewage disposal and water distribution facilities to the Property in advance of the date at which said facilities would otherwise be available to the Property and of the payment by the OWNER to the CITY of all connection charges, permit fees and other costs presently required by ordinance or resolution of the City of Novi, it is hereby agreed:
 - 1. The OWNER shall be permitted to make a direct/temporary connection from the Property to the sanitary sewer, which is part of the City of Novi sewage disposal system, and the water main, which is part of the City of Novi water distribution system, such connections to be made in the manner and at the location to be determined by the CITY.
 - 2. Charges for connection to and for sewage disposal and water distribution services rendered to the Property shall be in accordance with the applicable ordinances and resolutions of the City of Novi including amendments, additions and reenactments thereto.
 - 3. The cost of the construction of all facilities necessary to connect the Property to the sewer and water system shall be at the expense of the OWNER.
 - 4. In the event that lateral sanitary sewers or water mains are constructed in the future to serve the Property, the OWNER shall, at the option of the CITY, disconnect from said sanitary sewer and/or water main and connect to the new lateral sewer or water main.
 - 5. In the event that lateral sewers or water mains are constructed in the future to serve the Property and the cost thereof is levied by way of special assessment, connection charge or otherwise against properties, benefited, including the Property, the OWNER agrees to pay such special assessment, connection charge or other charge to the CITY in accordance with the ordinance or resolution establishing the same whether or not the Property is actually connected to said lateral sewer or water main.
 - 6. In the event the sanitary sewer or water main is installed through a payback arrangement or payback district, the OWNER agrees to pay to the CITY their proportionate share of the sanitary sewer or water main installation in one lump sum upon notification from the CITY.

- 7. In the event a petitioning effort is ever initiated, the Property will be considered an unconditional YES vote in favor of the sanitary sewer or water main installation in the City of Novi whether or not an actual petition is ever signed. This includes any efforts by surrounding property owners or the City of Novi regarding the installation of the sanitary sewer or water main.
- 8. This AGREEMENT shall be binding upon the parties hereto, their heirs, successors, legatees, devisees and assigns and the original of this AGREEMENT shall be recorded in the Office of the Register of Deeds.
- 9. The OWNER hereby warrants and represents that he/she is the owner of the property above-described, understands the provisions of this AGREEMENT and fully agrees to abide by the terms hereof and bind the above property to the provisions hereof.

Dear Mr. Croy:

We have received and reviewed the Agreement for Direct/Temporary Connection to Sanitary Sewer and Water Main provided by Anthony and Laura Paulk for the property located at 24561 Glenda. The Agreement is for the purpose of authorizing a temporary connection to the City's public water and sanitary sewer systems by connecting through a temporary water line and sewer lead through the adjacent properties. The Agreement requires the applicant to disconnect from the temporary connection at the time a permanent connection becomes available. The applicant will be required to participate in any future special assessment or pay the proportionate cost required to connect to a new water main or sanitary sewer. All other standard connection and permit fees must be paid at the time the temporary connection is made.
