BACKGROUND INFORMATION:

The City of Novi received the attached letter from the Oakland County Treasurer which identifies foreclosed properties under Act 123 of 1999 for failure to pay taxes. Under MCL 211.78(M)(1), the County is given a right of first refusal, and if it does not exercise that right the City gets the next "option" to purchase the property for a "public purpose."

The City received the attached letter from Oakland County about the tax foreclosed properties that did not sell at the August auction. An aerial photograph is attached showing the location of the property. The unpaid taxes and interest total \$1,286.82, plus additional fees, charges, or other costs as determined by the County and as required by law.

The staff's recommendation is to purchase this property as a public benefit due to its close proximity to Pavilion Shore Park.

WHEREAS, the City Novi has received notice from the Oakland County Treasurer that certain properties within the City have been foreclosed upon for unpaid property taxes, and that the redemption periods have expired without the properties having been redeemed;
WHEREAS, following Oakland County, the City of Novi has the right of second refusal to purchase this property;
WHEREAS, the foreclosed property having the Tax Parcel Identification No. 50-22-11-101-004 (the "Property") is located in the City of Novi Section 11: Howell's Walled Lake Sub Lot 26;
WHEREAS, it would be a public benefit because of the close proximity to Pavilion Shore Park; and
WHEREAS, the City Council has determined that it would be in the public interest to

purchase this Property.

- 1. The City Council of the City of Novi hereby expresses its desire to acquire the Property in accordance with the procedures of Act 123 of Public Acts of 1999 as amended.
- 2. The City Council hereby authorizes a purchase price of One Thousand Two Hundred Eighty Six Dollars and Eighty Two Cents (\$1,286.82), plus additional fees, charges, or other costs as determined by the County and as required by law for the Property.
- 3. Since Oakland County has exercised its right of first refusal to acquire the Property, the City shall proceed with the acquisition of the Property, and the Mayor and City Clerk are hereby authorized to execute any and all agreement and documents necessary for such purposes, upon the review and approval of same by the City Attorney.
- 4. A signed copy of this Resolution shall be forwarded to the Oakland County Treasurer before October 8, 2014.



Dear Loca! Treasurer,

On August 18 – 20 we completed our 'minimum bid' auction of tax foreclosed properties, recovering about \$3.5 million in taxes, fees and interest that will not be charged back.

In comparison to last year, the County outperformed the 2013 auction by more than one million dollars despite offering 23 percent fewer properties. The 340 properties and parcels that sold at the August auction garnered \$9.9 million.

Properties that sold are now back on the tax rolls, which boosts property values and stabilizes neighborhoods in communities across Oakland County. The average selling price at the August auction was \$29,382; \$2,339 more than last year's average selling price and almost \$10,000 more than 2012.

We are continuing our efforts to connect tax foreclosed properties with families through our mortgage program that allows families to get pre-approved through the mortgage lender of their choice, and then to bid up to that amount at the auction. And, we continue to introduce new policies to make the auction process better. This year, bidders were required to register before the 2014 auction, and those who owed back taxes or lost property in tax foreclosure proceedings were prohibited from bidding. This new process maintains the integrity of the sale as well as those of our property values and neighborhoods in our cities, villages and townships.

Any properties that did not sell at the August auction will be available through the right of first refusal to the State, Cities, Villages and Townships, as well as to the County, prior to the October 20-21 Land Sale. The Right of First Refusal dates are as follows:

September 15-19 - State of Michigan

September 22-26 - Cities, Townships and Villages

September 29-October 3 - Oakland County
