# MAYOR AND COUNCIL ISSUES:

Boomer University – Member Poupard commended the Older Adults Committee and the Novi Library for working with Oakpointe Church by sponsoring Boomer University on Saturday with an attendance of nearly 1,000. She also commended the Novi Fire Department who worked in collaboration with St. John Providence Hospital to provide services to those attending.

# CONSENT AGENDA REMOVALS FOR COUNCIL ACTION:

G. Approval to award a construction contract for the Fire Station #3 Parking Lot Improvements project to Nagle Paving Company, the low bidder, in the amount of \$92,010, subject to final review and approval of form of agreement by City Manager's office and the City Attorney, and approval of an additional appropriation in the amount of \$32,100 for this budget line item.

Member Mutch was concerned with an expenditure of over \$100,000 for the Fire Station. He explained the last time Council discussed Fire Station #1 and #3 was in 2014 at the Budget Goal Setting Session. For both goals, City Administration talked about providing more information about what direction to take regarding the buildings. The Stations have particular problems with the size and location of the current facilities. Part of the discussion in 2014, was that Station #1 may not fit in the long term vision of what the Main Street area should look like. The #3 station on Nine Mile is a small piece of property and never designed to be used the way it is being used. He said it was okay for the item to go forward but he wanted to see from City Administration their input on where the City needs to move on those locations. At a future date, Council could have a conversation about them. His impression was that they had provided clear direction to City Administration. He didn't feel it was done. He didn't want a pattern of throwing money at these Station locations while addressing short term needs when there are possibly long term questions that should be answered.

Member Poupard asked for clarification from Member Mutch as to the questions he raised and then his support.

Member Mutch thought it was appropriate to raise the question, since it was on the agenda. He thought City Administration should supply information on this issue. He was asking for City Manager Auger's fresh perspective about it in the future conversations but didn't want to hold the item up.
