- \* Set up begins at 10am on Friday, November 19.
- \* Vendor booth display areas are approximately 10' wide by 10' deep Vendors may request an additional booth.
- \* Vendors will not need to bring a tent. The market will provide large tents to accommodate multiple vendors and electricity. Tents will be heated.
- \* Vendors are responsible for their own set up and tear-down, including providing auxiliary lights, etc. \* There is no application fee. It is free to apply, however, applications will be evaluated to ensure
- exceptional quality and a diverse product mix. Selections will be made by October 18.
- \* If selected, cost for a single vendor booth is \$200. Double booth cost will be \$350.
