There are no outstanding legal issues concerning the contract for the Purchase of NG9-1-1 equipment and services with Motorola Solutions, Inc., formerly known as Emergency CallWorks, Inc., for 911 Equipment and Services.

The contract is based upon the agreement between Oakland County and Motorola for the purchase of next generation 911 equipment and services. The City's contract indicates the sections in the County agreement that do not apply to the City contract and provides alternative language, where applicable.

If the contract is approved, the City will agree to abide by the terms of the agreement between the County and Motorola. The City will be considered a user of the software provided through the license received by the County.

Motorola's liability to the City for all claims except personal injury or death, will be limited to \$74,410, which is the cost of the equipment and services.

The city of Novi was responsible only for the local remote workstation hardware and maintenance of that hardware.

Although the warranty for the City of Novi does not expire until May 30, 2022, the County contract expires in December of 2021. Subsequently, Oakland County has negotiated a five year warranty extension and hardware refresh for all Dispatch Centers, including the City of Novi. The new warranty end date is January 31, 2026. The goal of the County is to have all local Dispatch Center contracts expire on the same date as the County, January 31, 2026. Motorola has prorated the cost of the City of Novi warranty renewal based on the number of workstations and length of time between the end of our current contract (May 30, 2022) and the end of the extended contract negotiated by Oakland County (January 31, 2026). That prorated time frame is three years and seven months and affects only the warranty portion of the costs. Although this project was anticipated, final costs were unknown until provided by Thomas Gavin, Solution adviser at Motorola Solutions, on June 21, 2021.

CONTRACT FOR THE PURCHASE OF NG9-1-1 EQUIPMENT AND SERVICES

The Parties hereby enter into this contract, effective on , 2021 ("Effective Date"), between Motorola Solutions. Inc. f/k/a Emergency "ECW") CallWorks, Inc. ("MSI" or and City of NOVI ("City of NOVI"), for the purchase of Next Generation 911 Equipment and Services ("End User Contract").

Whereas, MSI and the County of Oakland, MI, entered into a Contract (No. 004698) for the purchase of Next Generation 911 Equipment and Services ("Contract"), which was amended (under Amendment 3) December 18, 2020 to, among other things, update Exhibit VI to reflect new pricing for Non-Oakland County users and extend the term of the Contract through January 31, 2026. A copy of the Contract and Amendment 3 (collectively referred to herein as the "Primary Contract") is attached hereto and incorporated herein by reference as Exhibit A.

For an amount not to exceed \$74,410.00, <u>City of NOVI</u> agrees to abide by the terms and conditions of the Primary Contract, including its Exhibits, and whenever "County" is referred to in the Primary Contract, and only for purposes of this End User Contract, it will have the same effect as referring to <u>City of NOVI</u>, except as set forth below:

1. Section 5.1 of the Contract shall be replaced in its entirety with the following:

a. <u>Performance of Deliverables</u>. Contractor shall provide all Deliverables and Equipment identified in and as set forth in Exhibits II and VI or any Amendments to the Primary Contract.

2. Section 5.2 of the Contract is hereby deleted for purposes of this End User Contract.

3. Section 5.4 of the Contract shall be replaced in its entirety with the following:

a. <u>Financial Obligations</u>. Except as otherwise set forth in this End User Contract, City of NOVI sole financial obligation hereunder shall be set forth Exhibits IV and VI of the Primary Contract. The amount and manner of payment of the financial obligation shall be a Purchase Order based on its respective amount in Exhibit VI of the Primary Contract.

4. Section 5.5 of the Primary Contract shall be replaced in its entirety with the following:

- a. <u>Payment Obligations</u>. Except as otherwise set forth in Exhibits II, IV and VI, Contractor shall submit an invoice to <u>City of NOVI</u> Contract Administrator, or equivalent, itemizing amounts due and owing under this Contract, as of the date of the invoice. Invoices shall contain the following information: (a) County Contract Number; (b) itemized list of Deliverables;
- (c) Contractor Tax ID Number (federal and State); and (d) any other information reasonably requested by City of NOVI shall have no obligation to make a payment under this End User Contract until an invoice is submitted in the form set forth herein and shall have no obligation to pay for Deliverables. which have not been invoiced (as required herein). Unless otherwise set forth in Exhibit II, City of NOVI shall only Contractor for Deliverables under this End User Contract and not any subcontractors or assignees of Contractor.

5. Section 7.4 of the Primary Contract shall be replaced in its entirety with the following:

a. <u>Limitation of Liability.</u> Except for Claims resulting in personal injury or death, Contractor's total liability, whether for breach of contract, warranty, negligence, strict liability in tort, indemnification, or otherwise, will be limited to the direct damages recoverable under law, but not to exceed One Hundred Twelve Thousand Dollars (\$74,410.00). ALTHOUGH THE PARTIES ACKNOWLEDGE THE POSSIBILITY OF SUCH LOSSES OR DAMAGES, THEY AGREE THAT NEITHER PARTY WILL BE LIABLE FOR ANY COMMERCIAL LOSS; INCONVENIENCE; LOSS OF USE, TIME, DATA, GOOD WILL, REVENUES, PROFITS OR SAVINGS; OR OTHER SPECIAL, INCIDENTAL, INDIRECT, OR CONSEQUENTIAL DAMAGES IN ANY WAY RELATED TO OR ARISING FROM THIS CONTRACT, THE SALE OR USE OF THE DELIVERABLES OR SOFTWARE, OR THE PERFORMANCE OF SERVICES BY CONTRACTOR PURSUANT TO THIS CONTRACT. This limitation of liability provision survives the expiration or termination of the Contract and applies notwithstanding any contrary provision.

6. City of NOVI hereby agrees to abide by the terms, conditions, limitations and restrictions contained in Exhibit III (Software License Agreement) of the Primary Contract and further agrees and acknowledges that:

- a. The County of Oakland is purchasing and is thereby granted all personal, limited, non-transferable and non-exclusive Software licenses under the Primary Contract as more fully described in Section 3 of Exhibit III.
- b. City of NOVI will not be a Licensee of the Software under the Primary Contract,
- c. City of NOVI is a user of the Software under the Primary Contract.

7. Exhibit IV – Maintenance Agreement of the Primary Contract, is hereby modified as follows:

- a. Section 2.1 is hereby replaced with the following:
 - i. Fees for services under this Agreement are set forth in Amendment 3 to the Primary Contract (see Exhibit A).
- b. Section 3.3 is not applicable to this Contract.
- c. Schedule A ``7x24x365 Service 4-hour On-Site Response Fee Schedule' shall be in accordance with Exhibits II & VI of the Primary Contract.
- d. Schedule A "Spare Parts Kit COUNTY Site Location(s)" is not applicable to this Contract.

Unless otherwise defined herein, all ca	pitalized terms shall have the meaning set forth in the Agreement
(as defined below).	

RECITALS

- A. WHEREAS, County and Contractor entered into that certain Contract Number 004698 effective February 1, 2016 (Agreement"), whereby Contractor agreed to provide and County agreed to purchase NG911 Call Processing Equipment, including hardware, software, implementation services ("System") and maintenance services to the County as further described in the Agreement.
- B. WHEREAS, the Agreement expires January 31, 2021 and the parties wish to amend the Agreement to extend the Term to January 31, 2026.
- C. WHEREAS, in accordance with Section 2.2 of the Agreement, County and Contractor desire to memorialize the foregoing and to provide for other changes to the Agreement, all on the terms and conditions as set forth herein.

AGREEMENT

NOW THEREFORE, for and in consideration of the above premises, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Contractor hereto agree as follows:

- 1. <u>Extension</u>. Section 2.2 provides that the Agreement may only be extended by mutual written agreement. The parties agree to extend the Agreement to January 31, 2026 ("Extended Term").
- 2. <u>Contract Price</u>. The total Contract Price for this Extended Term shall be \$2,591,389.46. This contract price shall be separated out by Oakland County Contract Pricing and Non-Oakland County Site Pricing.
- 3. <u>Exhibit V Oakland County Site Pricing.</u> For the Extended Term, updated pricing for Exhibit V Oakland County Total Site Pricing is \$1,422,218.62 and is attached hereto and incorporated herein by reference.
- 4. <u>Exhibit VI Non-Oakland County Site Pricing</u>. For the Extended Term, updated pricing for Exhibit VI Non-Oakland County Site Total Pricing is \$1,169,170.84 and is attached hereto and incorporated herein by reference.
- 5. <u>Effective Date</u>: The effective date of this Amendment shall be February 1, 2021.
- 6. <u>References</u>. All references to "Emergency Callworks" shall be revised to "Motorola Solutions, Inc.

5. <u>Conflict/No Other Modifications</u>. In the event of a conflict between the terms of this Amendment and the terms of the Agreement, this Amendment shall control. All other terms of the Agreement shall remain unchanged and remain in full force and effect.
