Janine McKay, 30742 Tanglewood Dr., Novi said she was currently the President of the Maple Greens Board. She brought up the issue of speeding throughout their community. She said their roads are private roads, and the Novi Police Department have told them they cannot do anything for them because they are private roads. She said that does not help them. She stated they have put this issue in their newsletters numerous times, they talk to their co-owners during their meetings about the speed and it is not just our co-owners that are speeding. She said there was a GFL truck today that must have gone past her house at 50 miles an hour as opposed to 20 miles per hour, and it is an ongoing issue. She noted that there is only one street with sidewalks, and all the other streets throughout the Maples of Novi do not have sidewalks which means we take to the streets

literally to walk, ride our bikes, walk dogs, and put our kids in a stroller. She said it is a danger with cars parked on the side of the road and walking between them is a danger to us. She said they do not know what else to do. She felt the need to come here that evening and implore you to see if there is anything that the City Council or someone within the City can do to help them solve this situation. Member Casey asked Chief Johnson wondered if the Stryker equipment will come in any earlier. She said the delay is going to be just how long it takes to build a tanker, so is it planned for the Stryker equipment to come in any sooner and used on our current vehicles. Chief Johnson said he was not certain when they plan on purchasing that, we will not actually pay for any of the truck or equipment until it arrives. He thought we were looking at 27 to 29 months. He stated the Stryker equipment is something new that we use. It is a life supporting measure that does CPR, and it is very effective. He said we are please to be able to have that piece of equipment. He stated it is not necessary for us to have it because it will get replaced when the truck arrives. Member Casey said that was wonderful and thanked him for his response.

Mayor Gatt wondered if Chief Johnson could describe in detail how the pumper works. Chief Johnson said it is simple. He said it is the same as the water system, that keeps pressure in the water lines, the fire hydrants, and your spigots at home. We need to keep the pressure in our fire hoses and at a certain pressure for them to operate most efficiently. He explained that it depends how many hoses that you pull off at a fire incident, it's how you adjust and regulate the amount of pressure. He said essentially, we are just taking that the fire hydrant and extending it into the fire hoses. He stated typically, where pressures of anywhere from 100, 150, to 300 PSI. He said you can literally knock someone down with those types of pressures. He said we do not use our fire hoses to knock people down, but they knock down the fire. He said that is the intent, so we are please to be able to do that. Mayor Gatt asked how long the hoses were. Chief Johnson replied that most of them are 50 feet in length, but they have couplings so we can extend them thousands of feet if we need to. Mayor Gatt asked if that reduces the pressure as you extend it. Chief Johnson said it does, it is called friction loss.

### 4. Consideration of proposed water & sewer rate resolutions for 2022-2023

Mayor Pro Tem Staudt asked if our financial expert thought the proposed rates were justified. City Attorney Schultz said they were justified. Mayor Pro Tem Staudt said we've been able to limit the amount of our water rates because of our water storage capabilities. How does this reflect that? Finance Director Johnson said there were multiple factors that have allowed the City to see very small increases over the past seven years. There were large projects being completed and savings of more than \$3 million due to the water storage facility. He said all of those things have allowed us to pass on increases much less than DWSD and the county. We aren't passing along the cost that is passed on to the City. They have another large project recently approved to address asbestos piping. Mayor Pro Tem Staudt asked what percentage of what we pay in water and sewer rates goes to infrastructure. Finance Director Johnson said that varies annually.

Mayor Pro Tem Staudt asked what the Great Lakes Water Authority's role was in setting rates. Finance Director Johnson said they set the wholesale rate and we set the retail rate.

Mayor Gatt said there is a community that doesn't pay their water bill and he wanted to know if the City of Novi was paying for that community's bill. Finance Director Johnson said no, the City of Novi is only paying for its own usage.
