BACKGROUND INFORMATION:

Each year, the City of Novi selects residential streets for reconstruction, repaving, repair, and/or rehabilitation based on PASER ratings, staff's field observations and resident The 2015 program consists of three separate contracts: Contract 1 for improvements to White Pines Drive (currently under construction), Contract 2 for asphalt streets, and Contract 3 for concrete streets (elsewhere on this agenda for consideration). Altogether, the City will be making an investment of \$3,700,000 in neighborhood streets this construction year.

One of the primary goals of the Department of Public Services' asset management program is the preservation of the City's roadways to prevent costly reconstruction. Novi's neighborhood road and preventative maintenance programs are intended to result in an overall improvement in the quality of the City's roadways and consequently increase the overall PASER rating for the roadway network. The neighborhood road program will typically address large sections of streets that require significant rehabilitation. Rehabilitation techniques that will be considered include standard methods, such as mill and overlay, partial-depth and full-depth joint repairs; and will also include other emerging technologies such as pavement interlayers, asphalt recycling, full-depth reclamation, and the use of other materials and methods that improve the strength of the pavement and resistance to reflective cracking. The objective is to preserve good quality roads using lower-cost rehabilitation techniques, rather than allowing the roads to deteriorate to a point that requires road reconstruction involving much more effort at a higher cost. This type of rehabilitation is intended to limit further deterioration of existing pavement defects, and extend the service life of the pavement.

The streets selected for this contract include all of the streets in Orchard Hills Subdivision as shown on the attached map.

Four bids were received and opened on August 12, 2015 following a public bid solicitation period. The lowest responsible bidder is Cadillac Asphalt. Cadillac's bid is recommended as being in the best interest of the City as it is responsive (i.e., Cadillac has complied with all requirements of the bidding instructions) and it is the lowest price. Cadillac has successfully completed work for the City in the past.

(OHM's award recommendation letter including the bid tabulation dated August 13, 2015 is attached). A summary of the four bids is as follows:



Recommendation of Award

Dear Mr. Croy:

Sealed bids for the 2015 Neighborhood Roads Asphalt Program were received and publicly read aloud by the City on Wednesday, August 12, 2015 at 2:00 pm. Proposals were received from four (4) bidders. The four (4) bidders and their bid amounts are summarized below and in the attached bid tabulation. The final Engineer's Opinion of Construction Cost for this project was estimated to be \$1,319,000. Please note that these amounts listed below include the cost of crew days (inspector days) for the project.

The project scope consists of reconstruction of the existing asphalt 2-lane roads (approximately 7,300 feet of roadway) within the Orchard Hills Subdivision, including other miscellaneous improvements such as minor swale grading, isolated driveway approach replacement, isolated culvert replacement, and related site restoration. The work to be completed under this Contract includes the furnishing of materials, equipment, and labor necessary to complete the proposed work, in accordance with the contract documents.

Cadillac Asphalt, LLC, located in Wixom, Michigan, is the apparent low bidder. They have successfully completed previous recent projects for OHM in multiple communities in Southeast Michigan, and have also worked previously on City of Novi projects. Based on our review of the bids submitted, and discussions with City staff, we recommend award of the 2015 Neighborhood Roads Asphalt Program project to Cadillac Asphalt, LLC, in the estimated award amount of \$1,209,821.50. Please note that this award amount is derived from the total bid amount of \$1,251,421.50, less the crew day cost of \$41,600, per the submitted unit price bid for the project by Cadillac Asphalt, LLC.
