

CITY MANAGER APPROVAL

BACKGROUND INFORMATION:

City staff was approached by Michigan State Fair organizers and Shriners International on the possibility of having a parade in conjunction with the event. The Shriners have requested to close this stretch of Grand River Avenue in order to have a parade leading to the Michigan State Fair site at the Suburban Collection Showplace from 9:30 a.m. to 11 a.m. on Monday, September 7. The Road Commission for Oakland County has issued a permit to the City allowing use of roadways under County jurisdiction for civic events. The permit is predicated upon the adoption of an Authorizing Resolution by the Novi City Council approving the event and agreeing to the terms of the permit.

The City of Novi will provide Department of Public Service workers to coordinate the closure and reopening of the road, and Police Officers will provide traffic controlling measures immediately before, during, and after the event. Representatives from the Michigan State Fair and Shriners will be overseeing the participants and staging the event. Grand River Avenue is expected to reopen no later than noon.

RESOLUTION 2015 Michigan State Fair Shriners International Parade

WHEREAS, the City of Novi has been issued an annual permit, Permit No. E 56051 by the Road Commission for Oakland County to conduct civic events on roads under the jurisdiction of the RCOC; and

WHEREAS, the validity of the permit is conditioned upon adoption of an Authorizing Resolution by the Novi City Council for the event and a statement agreeing to the terms of the permit.

NOW, THEREFORE, BE IT RESOLVED that Mayor and City Council hereby authorize and support the 2015 Michigan State Fair Parade and will fulfill all permit requirements, save harmless, indemnify, and represent the Board of Road Commissioners against any and all claims for bodily injury or property damage, or any other claim arising out of or related to the 2015 Michigan State Fair Parade.
