#### **BACKGROUND INFORMATION:**

The owner of the Suburban Collection Showplace is hosting the Motor City Comic-Con, from May 19 – 23, 2023. Certain adjacent properties of the exhibition property will be utilized for overflow parking and staging for exhibitors at the event.

The attached resolution provides for use of the several adjacent and nearby properties to the west, east and south of the Suburban Collection Showplace site. Due to the popularity of the event these additional sites as well as overflow/shuttle lots at the nearby schools will be used to limit the impacts of the visitors to the community.

**WHEREAS** the Motor City Comic Con is a popular yearly event that brings many visitors and significant economic impact to the City of Novi; and

WHEREAS, the event will begin May 19th, 2023 and runs through May 21st, 2023; and

WHEREAS, the proposal for the event has submitted by the BoCo Enterprises (with the BoCo as the formal "applicant" for the event), with the majority of the activities contemplated to be concentrated on the grounds of the Suburban Collection Showplace exposition facility, and with additional to be available on adjacent properties; and

**WHEREAS**, the City wants to see the event succeed, as it will both continue a positive tradition within the City and positively influence the surrounding areas in the City; and

WHEREAS, the City Council has determined that the City Council's approval is required under the City's zoning ordinance for that portion of the event located on the Suburban Collection Showplace and that the approval of the Public Safety and Community Development Departments is required as well for use of the adjacent property.

**NOW, THEREFORE, BE IT RESOLVED** that the proposed Motor City Comic Con use on the Suburban Collection Showplace property (parcel number 50-22-16-251-024) is hereby approved by the City Council pursuant to Section 3.1.15.C.x of the City of Novi zoning ordinance, subject to the following conditions under Section 3.25.I, "Conditions for Outdoor Recreation Uses":

- The applicant shall have in place and shall provide to all of its appropriate agents and employees, an emergency evacuation plan to be reviewed and approved for the event by the City of Novi Department of Public Safety.
- 2. The use of Parcel 50-22-300-094 shall be in accordance with the current Soccer Fields agreement. Under Section 7.2.B, Parcels 50-22-15-301-008, 50-22-16-176-019, 50-22-16-151-005,22-16-151-004, 50-22-15-151-008, 50-22-16-300-018, 50-22-16-251-024, 50-22-16-451-050, 50-22-16-451-051, 50-22-15-301-010, 50-22-152-007, 50-22-16-176-020, 50-22-16-176-021, 50-22-16-300-094, 50-22-16-426-001 and 50-22-16-426-002 will be used for paid event parking only. Parcel 50-22-16-176-028 (former Wix Mix) will be used for participant vehicle storage. These parcels are delineated in the attached application and maps.
- 3. Emergency access to all areas of the property shall be maintained throughout the entire event.
- 4. Parking or disturbance is not authorized within Wetland, Woodland or associated buffer areas. Clearing and grading of the parcels is also not authorized.

- Copy of Certificate of Liability Insurance. Guidelines for insurance shall be as follows (types of coverages required may vary depending on the specific event and activities):
  - A. Commercial General Liability Insurance on an occurrence basis with limits of liability not less than one million dollars (\$1,000,000.00) per occurrence and two million dollars (\$2,000,000.00) aggregate combined single limit for Personal Injury, Bodily Injury, and Property Damage.
  - B. Workers' Compensation & Employers' Liability Insurance, Michigan Statutory Limits of Liability.
  - C. Motor Vehicle Liability Insurance, including Michigan No-Fault Coverage, with limits of liability not less than one million dollars (\$1,000,000.00) per occurrence combined single limit for Bodily Injury and Property Damage. Coverage shall include all owner vehicles, all non-owned vehicles, and all hired vehicles.
  - D. Liquor liability, if applicable, in an amount of one million dollars (\$1,000,000) per occurrence, of one million dollars (\$1,000,000) aggregate.
  - E. All certificates of insurance, other than Workers' Compensation & Employers' Liability Insurance, shall name the City as an additional insured.

Such coverages shall be procured and maintained with forms and insurers acceptable to the City. Certificates of insurance acceptable to the City shall be submitted prior to commencement of the gathering or assembly.

Such insurance shall remain in full force and effect in the specified amounts for the duration of the permit. The insurance shall include an endorsement to the effect that the insurance company shall notify the City Clerk in writing at least ten (10) days before the expiration or cancellation of the insurance.




