**BACKGROUND INFORMATION:** City Council approved the purchase of 55 hot water heaters at Meadowbrook Commons in the FY 2016-17 budget to replace the original units purchased in 2001. Units are being purchased in bulk in order to secure better contracting and material rates.

Eight (8) bids were received and opened on June 21, 2016, following a public bid solicitation period. Staff is recommending the award to Maza Construction Engineering, who was the lowest bidder. Maza met all of the requirements listed in the request for proposals.

The replacement of hot water tanks is scheduled to begin in mid-summer and will be substantially complete by September.




