SUBJECT: Approval of resolution adding Precinct 22 to the Northwest boundary of the City due to population growth and move Precincts 20, 21 and 22 to a permanent location of Novi Middle School (Precincts 20 and 21) and Deerfield Elementary (Precinct 22).

### **BACKGROUND INFORMATION:**

With the population growth in the northwest section of the City, it has become necessary to split Precinct 21 utilizing Novi and South Lyon school district boundaries. Precinct 21 currently has over 2600 registered voters. Plans have been submitted that will add 277 homes within Andelina Ridge, Berkshire Pointe and the Preserve of Island Lake.

With Council's approval, it is being proposed to add Precinct 22 that will be located at Deerfield Elementary School. Additionally, Precincts 20 and 21 will be moved to Novi Middle School. These changes were necessitated when it was determined that Oak Pointe Church was unable to accommodate the upcoming August Primary in 2016 and in future years. The City Clerk's office has an excellent relationship with Novi Community Schools and they have assured us that these 2 schools will consistently be made available well into the future.

The Election Commission met on November 19, 2015 and unanimously approved the proposal to add Precinct 22 and possibly relocate Precincts 20 and 21 to Novi Schools.

Section 3.1 of the Charter states that the Council shall fix the location of the polling places. Therefore, a resolution is attached for Council's consideration that details the proposed changes.

In order to begin the process with the Michigan Bureau of Elections, proposed changes must be approved by City Council and submitted by January 5, 2016.

RECOMMENDED ACTION: Approval of resolution adding Precinct 22 to the Northwest boundary of the City due to population growth and move Precincts 20, 21 and 22 to a permanent location of Novi Middle School (Precincts 20 and 21) and Deerfield Elementary (Precinct 22).

# APPROVING RELOCATION OF PRECINCTS 20 AND 21 TO NOVI MIDDLE SCHOOL AND ADD PRECINCT 22 TO BE LOCATED AT DEERFIELD ELEMENTARY SCHOOL

**WHEREAS**, the City of Novi has 21 voting precincts and 15 p olling locations, as established in 2008. Since that time, increases in population at the northwestern boundary of Novi has created a need add a precinct; and

**WHEREAS**, the planned precinct change was granted by the local Election Commission and must be approved by the City Council per Charter Section 3.1;

**WHEREAS**, the rearrangement of precincts are governed under Michigan Election Law, MCL 168.657, and must be submitted to the Michigan Department of State by January 5, 2016; and

**WHEREAS**, this proposed change will assist voters by reducing the number of registered voters in Precinct 21 from 2254 to less than 1500; and

WHEREAS, the polling location of Precinct 22 shall be at Deerfield Elementary; and

WHEREAS, the polling location of Precincts 20 and 21 shall be at Novi Middle School.

**NOW, THEREFORE, BE IT RESOLVED**, the Novi City Council approves the following relocation of Precincts 20 and 21 and addition of Precinct 22:


