SUBJECT: Adoption of a resolution of support for the Application for Trail License on ITC Property from the north property line of ITC Community Sports Park to just south of 10 Mile Road (Phase 1A and 1B of the ITC Corridor Regional Trail).

SUBMITTING DEPARTMENT: Department of Public Services, Engineering Division

CITY MANAGER APPROVAL

BACKGROUND INFORMATION:

A north-south regional pathway in the western portion of the City, known as the ITC Corridor Regional Trail, was included in the adopted City of Novi Non-Motorized Master Plan 2011. The proposed regional pathway would provide a connection between ITC Community Sports Park and Maybury State Park to the south and the City of Wixom to the north. The master plan shows this non-motorized pathway roughly following a corridor of property owned by International Transmission Company (ITC).

The first segments of the regional trail are now under construction within the ITC Corridor north of 11 Mile and through the Medilodge site (phase 3A). Engineering staff is currently working with Providence Park Hospital to acquire an easement to construct the connection between Medilodge and Beck Road (phase 3B), which is funded for construction. Those discussions with Providence Park have been over an extended time and have been challenging. The latest communication is that the only way to get the necessary easement from Providence would be to lower the pathway to better match the existing grades in the area, requiring significant grading and a substantial increase in the estimated construction cost. A budget amendment is forthcoming on this project. The attached maps provide additional detail.

The preliminary engineering for the "Greenways" component of the ITC Corridor Regional Trail (shown as Phase 1 on the attached map), which is the cross-country pathway connection between ITC Community Sports Park to Fire Station No. 4 at Ten Mile, was completed in FY12-13. Phase 1 was divided into two smaller phases. Phase 1A will consist of an approximate 1.25 mile long, 10-foot wide, asphalt pathway between ITC Community Sports Park and Nine Mile (see attached location map). Phase 1B would continue the path north from Nine Mile Road to Ten Mile, where a trailhead parking area could be located. The majority of Phases 1A and 1B will be located along the ITC Transmission Corridor or on ITC property.

To facilitate the proposed trail improvements within the ITC corridor, Engineering staff has made contact with ITC representatives to initiate a license agreement for this segment of pathway. A similar application was submitted in March 2011 to initiate a license agreement for the pathway that is currently under construction north of 11 Mile in the ITC corridor. The license agreement for that portion of the pathway was approved by City Council in July 2012.

One item required with the application (attached) is documented evidence that all municipalities and entities involved with the proposed trail officially support the license application. The enclosed resolution was prepared for consideration by the City Council for that purpose and to support the portion of the ITC trail shown as Phases 1A and 1B on the attached map, through the ITC corridor from ITC Community Sports Park to Fire Station 4. A preliminary design of the pathway route has been provided for additional information and may be modified somewhat as discussions occur with ITC and other stakeholders as part of the final design process.

The approved 2013-14 budget includes funding for the final design of Phase 1A of the Greenways portion of the overall project, which was awarded to URS Corporation in July 2013. The design of Phase 1A is anticipated to be completed in mid-2014. The construction of Phase 1A is not budgeted at this time, but is shown in the Capital Improvement Program for FY2015-16 in the conceptual estimate's amount of \$564,375. Phase 1B (the portion between Nine Mile Road and Fire Station 4) is not funded for design at this time, but is included in the application for the license agreement to provide a complete package to ITC.

The attached resolution in support of the pathway should be seen as the first step in the process for the application for license submittal, and is required for initial review of the pathway plans. Once a license agreement is drafted by ITC, and reviewed and approved by the City Attorney, it will be forwarded for City Council's consideration.

RECOMMENDED ACTION: Adoption of a resolution of support for the Application for Trail License on ITC Property for from the north property line of ITC Community Sports Park to just south of 10 Mile Road (Phase 1A and 1B of the ITC Corridor Regional Trail).

Please provide a brief description of the length and purpose of the proposed pedestrian trail: Proposed trail is approximately 2.2 miles long of which 1.65 miles would be located within the ITC corridor, extending north from the north boundary of ITC Community Sports Park near Napier Road and Eight Mile Road to a point north located 0.36 miles north and east of Nine Mile Road, where the trail would enter City property and continue to the terminus at Fire Station #4 at Wixom Road and Ten Mile Road. The proposed trail would be used for recreational and non-motorized transportation purposes. It would connect with other existing and proposed trails and sidewalks in the area and is considered the second phase of the planned Regional Trail Route on the west side of Novi.

- 5. Provide documented evidence that all municipalities or entities involved in the proposed trail officially support this application for license.
- 6. Provide a projected plan showing detailed information regarding maintenance requirements for the proposed trail. Please include maintenance schedule and anticipated expenditures.
- 7. Provide information regarding restrictions or other constraints that need to be considered when reviewing this application (i.e. wetland permits, funding deadlines, etc.)
- 8. Remit a non-refundable administrative fee of \$_____ per trail mile.





Singh Trail - Phase II (Legacy Parc Connector)



Proposed Non-Motorized Network

The proposed Non-Motorized Network recognizes that pedestrians and bicyclists are a diverse population and that no one solution will apply to all bicyclists or all pedestrians. Thus bike lanes and sidewalks / roadside pathways have been proposed along all the primary roads in the City. Some of these roads are more oriented to bicyclists and pedestrians than others as they carry fewer motor vehicles and will be designed such to keep motor vehicle speeds in the 30 to 35 mph range. Complementing the primary road system will be a network of neighborhood connectors and off-road trails that provide access to key destinations in the City while minimizing exposure to a large volume of high speed motor vehicles.





Fig. 3.1K. Proposed Regional Trail Connections in The City of Novi
