2. Consideration of approval of Change Order No. 4 to Florence Cement Company for Cranbrooke Drive Reconstruction, 9 Mile Road to Village Wood Road, in the amount of \$1,662,156.07.

Member Mutch said he was fully in support of moving this forward. This is a continuation of a project we started last year. Cranbrooke Drive is kind of a main connector through this area of Village Oaks and Lakewood Park Homes. He said you see a lot of traffic moving folks going to 9 Mile and 10 Mile using it, it absolutely needs to be done. He was concerned about one of the design elements of this project that they learned from staff which is changing the arrangement of the roadway through this area. He stated for those who are familiar with Cranbrooke Drive you will know that currently there is no curbing on the outside of the boulevard. You have a lane going north with the island median in the middle with some trees and then a lane going south. He explained that outside of those lanes are some asphalt shoulders that are approximately two and a half feet wide. They were put in place several years ago at a request of the residents primarily in Lakewood Park Homes because they have no sidewalks in that area. He said the area was developed at a time before the City required sidewalks. He said obviously sidewalks were not included as part of the original development. He said what has happed over the years is that people still like to walk and still like to bike were doing that in the roadway, which is not that, especially for a busy connector road, that is not ideal. He said at some point, they came to City Council, City Administration, and then pled a request to have these asphalt shoulders added to the site to widen the space so that there was at least some are from where folks could walk. He said as part of this reconstruction those shoulders are going away, they are going to be replaced with concrete gutters for drainage and he understood why that is happening. He did not know if the overall width is being widened, but the travel lanes are going from 19 feet down to 17 feet or 18 feet depending on where you are along that stretch. He was concerned that removing those shoulders, we were now creating a situation where those folks no longer have anywhere to walk safely. He did not want them walking in the road itself, but we are not providing them an alternative. He said there are a lot of people who live over there, it is a dense area, not only with Lakewood, but a lot of Village Oaks residents. He said folks have told him they utilize that walk along there to get down to the 9 Mile pathway that we built a several years ago. He said while he was supportive of moving this forward, he would also like to have City Administration look at within the City right-of-way, is there the possibility of adding a sidewalk, or a pathway, or just looking at it, it looked like the west side is the most feasible location to put that along the stretch of Cranbrooke that is being considered that evening. He said from Village Wood Road, south down to 9 Mile, so that residents who live there have a safe way to walk and we are keeping them out of the road. He stated he was over there a week or so ago, but he knew a couple of Councilmembers live in this area so they can speak more directly to it. He said driving Cranbrooke a week ago, he saw a woman pushing a child in a stroller. He said some folks might say you should not push a stroller on the shoulder, but that is the need that is out there. That is the reason he wanted to address this before or as part of this motion. He said he was looking for City Administration to look at what it will cost to add in the pedestrian path along this length of Cranbrooke Drive. He was interested in hearing from a couple of the other Councilmembers that lived in the area, but he thought it was a reasonable request.

Mayor Pro Tem Staudt said he was one of the Councilmembers that lives in that area off Cranbrooke, and he said he drives that stretch frequently. He asked DPW Director Herczeg if this was intended to be concrete from the beginning or was this going to be a black top stretch and we changed that. DPW Director Herczeg replied that he thought that we looked at asphalt to replace this section, but when we had bids last year, concrete was more reasonable in priced than asphalt, so we decided to do all concrete in this section. Mayor Pro Tem Staudt said speaking on behalf of himself, who lives next to Cranbrooke, he thought they did a really good job in a very good timeframe. He was happy to see that we went to concrete for this project. He does see people walking in the street, which is very narrow because of the boulevard. He would like to see if the property exists, and we have the right-of-way to do it. He would like to see us put a sidewalk in, we had great foresight several years ago to put that sidewalk on 9 Mile and it proved to be a spectacular decision, it is frequently used and is a real benefit to the residents of that area. He thought a lot of residents from both Lakewood and Village Oaks would be very happy to see a sidewalk there. He said he did not want to hold up moving this forward because he thought approving this includes going out and doing engineering, we could do the sidewalks as a separate type of thing, but he did support if possible, having the sidewalks put in, and he moved to approve the project.

Member Casey said she was the other Councilmember who is a Village Oaks resident. She wanted to echo and provide her support that adding a sidewalk on this stretch is something that is going to be needed for the residents of this area. She agreed with Mayor Pro Tem Staudt's comment regarding people walking down Cranbrooke to get 9 Mile to do their walking, so we need to make sure that we are providing a safe environment for them.

Member Maday thanked Member Mutch for bringing this up. She said she supported the hope that we can get a sidewalk along there. She thought every resident deserves to be able to walk throughout our City and feel safe and comfortable. She said she was in full support of looking into the sidewalk as well.

Mayor Gatt said his daughter lives on Cranbrooke, he drives that road several times a week, and yes, there is a lot of traffic walking, old and young, babies, people riding bikes and we need a sidewalk there. He thanked Member Mutch for bringing this up.

City Manager Auger stated this is a follow up to the request that was made last Council meeting to move as quickly as possible to do some of these types of projects. We also brought on a person to reach out to seniors and others of need that may fall through the cracks and not necessarily sign up for our programs right now to see if we can assist them in any way to help them navigate through the labyrinth that is for signing up for COVID shots, etc. We have exposed a couple people to some of our ride programs and then transportation getting them to where they need to go. He said to look for further updates as we move along as far as our reach out program. He said this was the first step. He said they are also looking at Senior activity, they do not want to call them playgrounds, but devices that the seniors could use as well. He said they are looking at about three or four areas right now in the City that we think would get the most use. Mayor Gatt thanked City Manager Auger and staff. He stated this was a very important matter to all of us and our seniors, and our people with needs, our handicapped population, need our help, especially in this time of COVID.

Mayor Pro Tem Staudt expressed his appreciation for the quick response to Council's suggestions at the last meeting. He thanked the Mayor for reaching out and talking about those who need additional assistance. He though that was a great project and was happy to see it done quickly.

Member Fischer asked PRCS Director Muck was this in the CIP Program, when was this scheduled for replacement to begin with. PRCS Director Muck replied that there was a smaller version prior to this initiative that was scheduled, he believed for 2021-2022 CIP Program. Member Fischer said what is being replaced does not appear to be that old. He said he knew the north piece was put in in 2014 according to the packet. He said he was out there with his kids the other day and it was able to sustain his weight on it. He said he was impressed. PRCS Director Muck said it is time for that playground to be replaced. Playgrounds typically have a life cycle of 12 to 15 years; we have several certified playground safety inspectors on the parks maintenance staff who have continued to modify and adjust that playground. He said based on their recommendation as well, it is time, there are components that have worn out that we have not been able to replace. He said with the announcement of the new program, that seemed like a great fit and time to replace this. Member Fischer said some people probably remember playgrounds having a 25-year cycle with rust on them and everything else. He thought it is a good thing that we are replacing them even sooner just to make sure that all the mechanics are up to par. He also gave some kudos to PRCS Director Muck because he did an excellent job reaching out to the community, the school district, and other people to get some feedback on the inclusive nature of the park. He thought that is the spirit of exactly what the Mayor was going for, making sure that we are getting everyone out here, different needs met, that are not being met already, and pulling in the experts from the school districts to help us out. He gave him kudos on that, and he hoped that we continue to do that. He said we are investing a lot of money and he was fully in support of doing that. He said what he would like to see is that you seem to be doing it in a very strategic manner. He said he would like us to keep that up as well. He was fully in support of this with those comments in the record as well.

Member Maday echoed Member Fischer's comments. She was thrilled to see the collaboration that you reached out to the school district to figure out what they thought, and she was really looking forward to seeing the happiness that this brings to a lot of our community members and the people that live outside of our community that we can help since this is a very inexpensive thing and not every community is able to do. She was thrilled.

Mayor Gatt said if every Councilmember were given the opportunity, they would say the same thing. He said he would speak for everybody. He thanked PRCS Director Muck and his staff and City Manager Auger and his staff for everything. He said it is quick, it is classy, and it is the way Novi should always respond to our needs.

# AUDIENCE COMMENT:

Linda Hyaduck said she is the District Director from Senator Jim Runestad's office and was there checking in on the City of Novi. She said she wanted to know what is going on in the great City of Novi and to remind everyone that the Senator is available with any help or referrals or if anybody has any ideas. She said their office has a Facebook page, their website, or you can reach them via email at <u>SenJRunestad@senate.michigan.gov</u> or by phone at (517) 373-1758. She said she was really impressed with everything she was hearing about getting ready for spring and summer and it is making her look forward to being outdoors.

Remko Atteveld started off by quoting the City of Novi Open Government and Transparency Statement found on the City of Novi website it reads" the City of Novi takes pride in providing residents and business with comprehensive quality communications on all topics". He said as you might remember he spoke during the last City Council meeting and he wanted to provide some additional comments. He is the property owner at 21975 Garfield Road, adjacent to Garfield Lake and the issues with Garfield Lake and the surrounding wetlands and the damage has been documented in detail for the last 18 months by residents of the area he said with little to no response from City leaders. He said they have been turned down for relief at every point, the City Engineering Department does not believe the Nine Mile Projects to cause, the Assessor's Office will not grant them relief for real estate taxes due to declining real estate values, and 18 months of complaints have fallen on deaf ears. He said after many months of arguing back and forth, the City Engineer finally placed a hose in our lake which pump more than 205 million gallons, just for reference, that is more than 310 Olympic sized swimming pools into our lake with no change. He stated as of today, lake levels are down another five inches from the last time that he spoke, which was three weeks ago. He said it was not until residents decided to engage the rest of the community through a public post that three City leaders reached out to them, not with promises, but cautiously determining our state of mind and attempting to get the residents to identify the cause ourselves and come up with some solutions to a problem that we did not create. The response they received from the City was patient, we can determine the cause in just a few weeks, he said they have been patient. He said they heard that the issue of Garfield Lake will be discussed later this meeting during the Mayor and Council Issues part of the Agenda. He hoped you come away with tangible actions and solutions that will be communicated to the residents. He asked a minimum that the City leaders hold regular meetings with impacted residents of the area to discuss the cause and any solutions. Again, he quoted, the "City of Novi takes pride in providing residents and business with comprehensive quality communications on all topics".

Jim Bullock said he lived at 22015 Garfield. He mentioned he has had some conversations with a couple of the Councilmembers, and he appreciated that they have reached out to Remko and himself, but he did want to provide an update. He thought it was important to get perspectives from move than just one person. He echoed a lot of what Remko said, we were told that his was not a problem, he has had multiple conversations, emails going back and forth, and he was always told that this is nothing. He said it is nice to know, we are at least getting some progress here as far as agreeing that there is a

problem. He hoped there was going to be a solution rather quickly. He said it was nice to hear that when Council decided to take some action, within three weeks, something happened with something earlier today, so hopefully we are going to see that same kind of turnaround. He said one of the things that Remko and he bother mentioned, and it is certainly becoming more of a problem which is unrelated to the wetlands, but it is just the people that drive Garfield Road. He said Council mentioned earlier about the safety of people walking up and down the streets at Cranbrook. He said they do not have sidewalks on Garfield Road, the speed limit is 25 mph. He thought people are going conservatively about 35 mph, some of the, over 60 mph, it is just a matter of time before someone gets hit and their life is ruined forever. He hoped they could get some more police presence down this road for a little while just to kind of calm everything down. He reiterated his main concern was Garfield Lake the surrounding wetlands. He said he did have a certified geologist reach out the City as well. He hoped they will be able to work together with him and come up with a solution. He said they are ready to try to do what we can to help. He said communication would certainly be helpful if there is a little bit more transparency. He hoped they could fix that moving forward. He appreciated Council's time.

Mike Wilczynski said he was a Certified Professional Geologist with Pangea Environmental, LLC. He said he has about 40 years' experience as a geologist, most of it in hydro geology. He retired from the Michigan Department of Environmental Quality as a senior geologist as a professor at McLennan Community College where he taught geology. He really appreciated the time the consultant from OHM, he was supposed to send him an email. He said we had some time to talk this morning and agreed that better communication is needed between the City and the residents. He thought that they could work towards that. He said the consultant from OHM, and I have some mutual friends in the environmental industry. He thought that they worked well together trying to facilitate this. He said they became involved at the request of the Sierra Club when they were contacted by some residents. He explained they were asked to investigate reports of lower water and some possible causes. They did a preliminary hydrogeological investigation using readily available information and came up with the idea that the dewatering is causing the shallow aquifer to basically be destroyed or not destroyed, you are removing the water from the shallow unconfined aquifer and that is causing the problem. He said as you move further to the west, there is a bit the published geological maps show you might be encountering ever more groundwater. He said they have some concerns; the recharge and recovery of the groundwater level will not be a fast process. He asked how much further out and deeper this area of depression is going to continue. It is still dropping, that means it has not reached equilibrium, it is going to get worse. He was concerned because there is a possibility in the lower confining layer may have been penetrated, causing permanent lowering of the water table. He said this is based on his cursory examination of the well logs and its supports. This is a valid concern. He is currently involved in this type of situation at two locations in Kent County. He said both are related to sand and gravel mining where it appears a penetration lower confining layer has occurred. He stated the surface water and high-quality wetlands have been drained and the groundwater is not coming back at one location in Gains Township. The other natural spring along with Thornapple River are slowly being destroyed. He said these are real concerns. He said he would be happy to discuss the information that he has with your consultant and try to facilitate better communications between the City and the residents who deserve to know what is going on. He said we assert there is natural resource damage is already occurring and have occurred. Thank you for your time.

Gary Allison said he lived on Garfield for nearly 50 years. He moved when the lake was a gravel pit, so he was very familiar with it. He said the lake levels are normally very high in the springtime, they get lower in the fall. He stated this year it has been reversed. There are very low light levels, it seems to be getting lower. He agreed with what Remko said, and he also added that the communication with the residents has not been good. He said often they really do not know hat is going on, so he hoped communication improves. Thank you very much for listening.

City Clerk Hanson read email correspondence for the record from Alice Albu. She said that she and her Mike Albu live in the Meadowbrook Lake Subdivision. Their property is next to the branch of the Rouge River that empties into Meadowbrook Lake. She was writing to urge the City Council to support the Stream Bank Stabilization and Meadowbrook Lake Dredging Proposal at the April 12, 2021 City Council meeting. She said earlier this week she sent photos of an extended "caved in" area on the stream bank to DPW Director Herczeg. She stated this area was present in 2020 and now has extended. The tree in the photos is holding the bank in place. However, the soil is starting to erode around the tree. She said the erosion also continues to become nearer and nearer to their flower beds. She stated Mr. Herczeg responded promptly and let them know that the above proposal was on the City Council Agenda. She said the erosion of the stream bank is a safety issue for their family and their lawn service people. She said they had an Easter egg hunt at their house and had to caution their grandchildren not to go near that area. She stated that after heavy rain, there is extensive flooding in the yards of their neighbors across the street. She said due to the sediment accumulation in Meadowbrook Lake, the properties on the northwest portion of the lake are being devalued. She requested that the City Council approve the Steam Bank Stabilization and Dredging of the Lake Proposal.

City Clerk Hanson read the email correspondence for the record from Thomas Bateson. He stated he has been a Garfield Road resident for 23 years and has always enjoyed the beauty of Garfield Lake and ponds, which are adjacent to his property. He said the lake has attracted many kinds of wildlife, including waterfowl, muskrats, turtles, fish, frogs, and deer. It has been a vital habitat for them. This past year he has seen the water level of the lake greatly diminished and, in some areas, run dry. He said the protected state wetlands across from the lake are dry also. He said this is very disturbing to the residents and wildlife who enjoy Garfield Lake. He said something must be done to remedy this. He thanked everyone for their consideration of this matter.

Ron Debono said he lived at 21591 Garfield Road and he echoed the prior speakers and what they said regarding the damage to the wetlands, it has certainly been quite catastrophic and concerning. He guessed to potentially exacerbate the situation, there is now a proposed development immediately north of their property on Garfield Road at Eight Mile, and there was talk of drainage management for that property as part of this development. He said frankly they are very concerned that it is going to make the situation even worse. He said he would like to challenge and request, you, Mayor, and the City Council to commit tonight to some sort of further discussion and conversation regarding how we can address this.

# MAYOR AND COUNCIL ISSUES:

Mayor Pro Tem Staudt added "Garfield Lake" to Mayor and Council Issues. Mayor Pro Tem Staudt said the reason he put this on the Agenda that evening is as a City Council, and he is one member of it, he did not speak for all seven members. He thought is important that we acknowledge to the residents that first and foremost, we are aware of their issues. He stated that it is generally not our nature to get involved in projects like this, but this has escalated to a level where he thought it is important for them to let the residents know that they are aware, they are concerned, and that they are going to work with City staff to make sure there is a resolution to this project. He said none of them are geologists or hydrologist, and they do not have the answers themselves. He said they are policymakers and funders. He said one of the other things that is important is that he would like to give the City Manager an opportunity to talk about the project itself and how old this project is because they read on social media, we hear comments that his was prompted by the development across the street on Nine Mile and which could not be any further from the truth. He asked City Manager Auger if he could please give them a little bit of an overview as to the history of this project, what it is for, and why we are doing it, and why it is a necessity at this point.

City Manager Auger stated this project has been on the books a long time. He said he knew there is a new development going in at Garfield and Nine Mile Road and he has heard those same social media reports for that project. He said this goes way back before that. He explained there are grinder pumps in a force main on this area of road that needed to be another line run on the other side of the road, same style. He said that means every resident must have a grinder pump, there is mechanical things and when you get into the city system, we must do more mechanical things and they take high maintenance. He said the best solution overall is a gravity feed. He said once it is put in the ground, the gravity works. He said it is low maintenance and can handle the most sewage that way, this project was kicked down the road because it is such a tough project and when you are doing a project like this, it is 30 feet under the ground. He said there are a lot of unknowns. He said they tried to plan for as many as they can, but we did not anticipate hitting two rivers and some of the rock formation that we did not discover. He stated the other aspect of it is that we tried to keep the ambience of Nine Mile Road in all our plans. He stated that they did directional boring to try to save that tree canopy along that road and some of the ambience that people enjoy in that area, which adds to some of the challenges with this project. He stated this project was not made for economic development purposes, but long-term health of the whole area. He said they also have reports from the county that septic fields were failing in this area as well. He said this kind of addresses a long-term pattern and it was just something that kept getting punted because of the challenge of this project. It has taken a year longer than we anticipated. He said they totally understand the resident's discomfort, we

understand what is going on with Garfield Lake, and as soon as we get this project finished up then we can start addressing that. He said we must get the project finished up, hopefully in June we will be finished up with this sewer project and we can start seeing some results in the wetlands that you were just hearing about. Mayor Pro Tem Staudt thanked him for the explanation, he said he thought that it was helpful. He said it does not appear that we have a finite deadline for finishing this project and stopping the dewatering is that correct. City Manager Auger replied yes, that was correct. He said we are closing in, but he could not tell you an exact date. He said they still have some underground work to do. He said no one will be happier than our DPW when we get this project completed. He said they will try to keep everyone here that evening who wants more communication, different communication, they will try some different things and communicating where they are at and what is happening with this project. Mayor Pro Tem Staudt said in terms of communicating from him, as a City Councilmember and each Member could weigh in on their own. He was committed to making sure that there is a solution to this project, and that we provide adequate funding to complete that solution. He was also committed to making sure that we do this in the timeliest manner possible, working with whomever we need to work with to find the solutions. He asked is that was an acceptable commitment. City Manager Auger said we are on that page, that is what our anticipation is. He said when we finish up this project, we will start seeing hopefully some results and we will work with the residents and our ecologist to ensure it is done. Mayor Pro Tem Staudt said he has talked to several of the people who spoke that evening. He said you see it on Facebook, you see it on Next Door posts, we are only as good as the action that we provide. He said this City Council has never kicked the ball down the road and we have always permitted to working hard to fulfill the things that we promise, so in this situation, all we can do is tell you, it is on our agenda. We are committed to getting it done and we will work with City staff. He reiterated that City Council does not go out and do roads and we do not do projects, they are there to hold people accountable.

Mayor Gatt said he would not open this up to Council because this was Mayor Pro Tem Staudt's issue, but he speaks for all of us on this issue. He said we are all watching, and they all feel for all the residents, and he appreciated your City Manager Auger's action on this.

ADJOURNMENT – There being no further business to come before Council, the meeting was adjourned at 7:45 P.M.
