| 23 | Boulevard and Grand River Avenue. It also has a    |
| 24 | floodplain setback along the east and north sides  |
| 25 | due to the existing Rouge River going through the  |



property. The variance tonight we are seeking is to reduce the parking count by three. Due to studies conducted by Community Financial Credit Union, a majority of customers coming to this site are going to opt for the ATMs, which are very efficient, and allow for quick transit customers to deal with their banking.

In addition, we have proposed a reduced 8 footprint building at 3,000 square feet, which 9 allowed us to optimize our parking as much as we 10 could given the nature of the site. And Community 11 12 Financial Credit Union has informed us that 13 studies they've conducted on similar sites have 14 shown that filling up this many parking stalls 15 with a building this size is extremely unlikely, 16 and that, as I stated previously, most customers 17 will use the ATMs anyway. If you have any questions, I'll be here to answer. 18 19 CHAIRPERSON PEDDIBOYINA: Okav. Thank you. Okay. From the city? 20 Thank you, Mr. Chairman. 21 MR. HALL: Yes. He's seeking a variance to reduce his 2.2

23 parking count by three, and there is wetlands 24 nearby and he's surrounded by road, so this is a 25 tight site.

And 3 the difficulty that we have, the picture doesn't 4 5 really show this that well, I apologize for that, but right where the existing base is for that sign 6 7 right now, immediately it slopes down to a storm sewer at a very severe pitch. It would be 8 extremely difficult to put in a monument style 9 sign where the foundation would have to be much 10 longer and larger than the existing one. And so 11 12 what they're hoping to do is just to be able to 13 reuse the existing foundation that's there, put 14 the same size sign up that they've had for a number of years. And then also just I know it's 15 16 larger, not only taller, but larger than you would 17 typically see, but would ask you to consider if you drew a box around the word Citizens in the 18 19 logo, it's only 17 square feet of signage. So 20 that's all the text is in this. 21 CHAIRPERSON PEDDIBOYINA: Would you 2.2 like to add anything, Paul? 23 That will do. MR. DETERS: No. 2.4 CHAIRPERSON PEDDIBOYINA: Sounds good. 25 Okay. 1 be an issue. It's not grandfathered in so there's no obligation for the city to say there's a 2 3 preexisting condition, so you know that. When they asked for their monument sign it was nine feet I believe, and it 10 was more proportional to the whole site. And this 11 12 case they're trying to replace the pole sign with a similar sign only elevated, and I'm not inclined 13 14 to support it. 15 CHAIRPERSON PEDDIBOYINA: This is my 16 concern too. I agree, Linda. I don't know why you want the 15 feet height. 17 MR. DETERS: One is just, they're 18 19 trying to keep it within that narrow profile 20 because of the difficulty of having to excavate

there where the grade pitches down significantly 21 to the storm sewer. The height enables them to 2.2 23 display their name vertically. If they go to a 24 monument sign, it will have to be horizontally, 25 and that would be more of a challenge, in addition



to the fact that it would put in all of that nice 1 landscaping because it wasn't an issue before with 2 3 the way the configuration of the sign. Now, most 4 of the shrubs that they planted are going to block 5 the text on the sign. 6 CHAIRPERSON PEDDIBOYINA: The text is 7 your issue, the bank's issue, not us. I don't know because until I don't know until on my side 8 9 until the traffic study proceeds and gives us the direction to the ZBA so that I can't move on this 10 11 case at present. 12 MR. And certainly the 3 sightlines for that are much farther away than the 4 wall signs are, and do help to identify for 5 prospective customers to come in to get in the 6 7 proper lanes to turn in. I understand where you're coming from, but the branding implications 8 for banks and retailers and restaurants, those 9 signs have proven to be extremely valuable and 10 11 effective for them.

12 MEMBER MONTAGUE: I was just by there today, and coming south on Meadowbrook, it is a 13 14 visibility issue. They don't have a sign on that 15 side so it does help identify that you should get 16 over and turn right into. You've got that first driveway and you kind of miss that before. So in 17 my view, it is necessary for getting people in 18 19 terms of traffic safety to get them in that lane to turn right to get into the bank because there 20 21 isn't one on the side.

CHAIRPERSON PEDDIBOYINA: I agree,
Member Montague. I agree. It's not a new bank.
It's been a bank more than two decades, I believe.
