
BACKGROUND INFORMATION: The Parks and Municipal Grounds Management Division currently has one Kubota utility tractor that is well past its expected life and will be placed out of commission with the purchase of this budgeted replacement unit. This machine is a critical tool within the Parks Maintenance Team. This tractor is operated daily for field maintenance, trail maintenance, snow removal, debris transportation and field grating. The new tractor is compatible with many of the attachments already owned by the City to accomplish these tasks such as a loader bucket, aerator, snow blower, and a rototiller.

The proposed Compact Utility Tractor is manufactured by John Deere and is part of their 4066M series. Some of the key features include:

- Powerful and reliable Yanmar Diesel Engine
- iMatch Quick-Hitch allows for easy implement hookup
