BACKGROUND INFORMATION:

The 2014 Novi Half-Marathon, held in partnership with the Novi Parks, Recreation and Cultural Services Department, the City of Wixom, and the City of South Lyon, will be held on Sunday, May 4th with the run beginning at 7:45 a.m. to 10:45 a.m. The route will start in the City of South Lyon at the South Lyon East High School. The Run will be utilizing Napier Road between 10 and 11 Mile Road along with roads along the Island Lake Sub-Division in the City of Novi.

The Road Commission for Oakland County has issued a permit to the City allowing use of roadways under County jurisdiction for civic events. The permit for the road closure is #54024.

- WHEREAS,** the 2014 Novi Half-Marathon, held in partnership with the Novi Parks, Recreation, and Cultural Services Department, the City of Wixom, and the City of South Lyon, will be held on Sunday, May 4th with the run beginning at 7:45 a.m. to 10:45 a.m. The route will start in the City of South Lyon at the South Lyon East High School. The Run will be utilizing Napier Road between 10 and 11 Mile Road along with roads along the Island Lake Sub-Division in the City of Novi. (See attached map and route for entire route); and
- WHEREAS,** the City of Novi has been issued an annual permit, the permit number being 54024, by the Road Commission for Oakland County to conduct civic events on roads under the jurisdiction of the RCOC; and
- WHEREAS,** the validity of the permit is conditioned upon adoption of an Authorizing Resolution by the Novi City Council for the event and a statement agreeing to the terms of the permit.

NOW, THEREFORE, BE IT RESOLVED that Mayor and the Novi City Council hereby authorize and support the 2014 Novi Half-Marathon and will fulfill all permit requirements, save harmless, indemnify, and represent the Board of Road Commissioners against any and all claims for bodily injury or property damage, or any other claim arising out of or related to the 2014 Novi Half-Marathon.

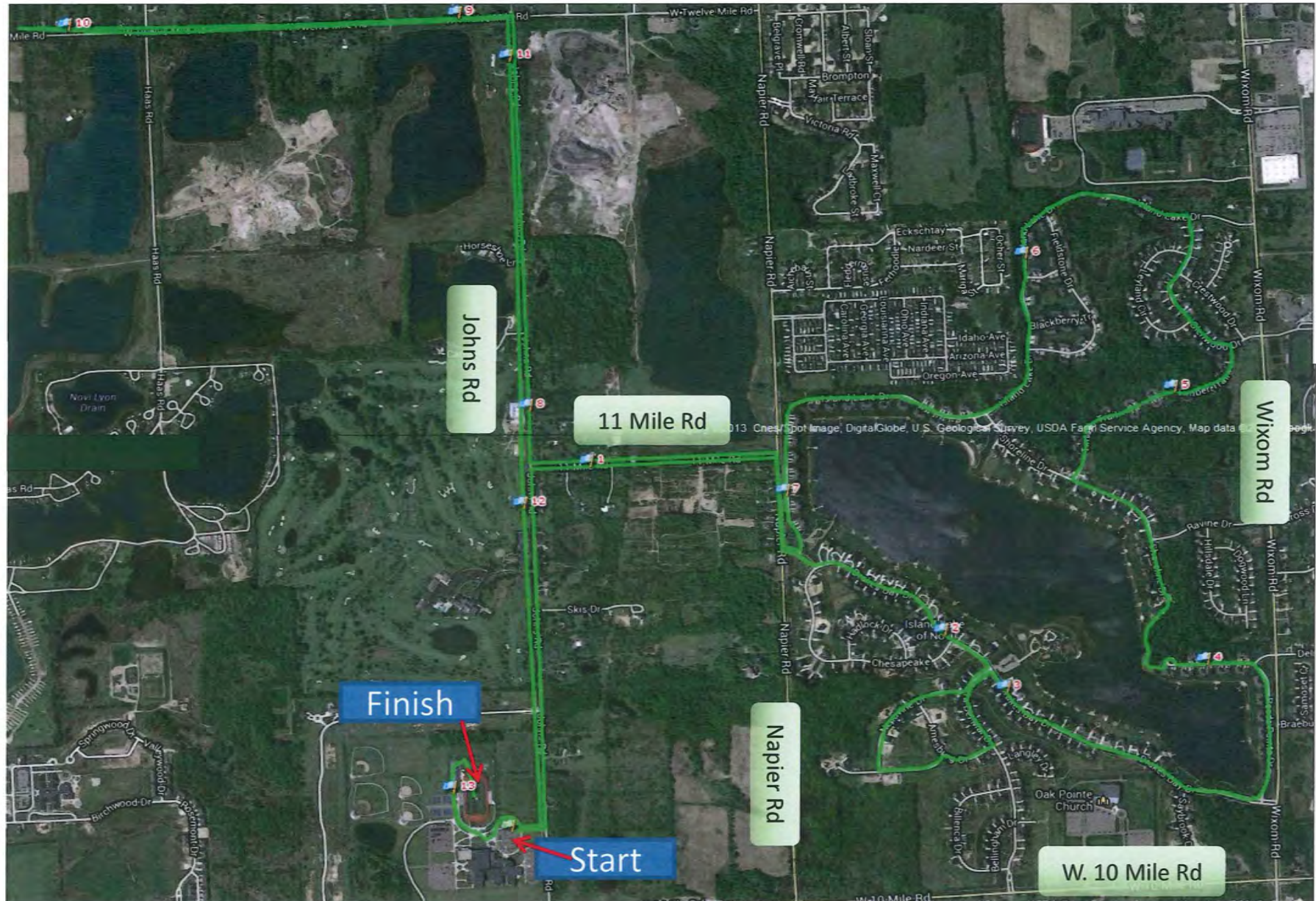

Turn by Turn Instruction

Start	South Lyon East High School		
1	Turn left on Johns Rd.	13	Turn left on Island Lake Dr.
2	Turn right on Eleven Mile Rd.	14	Turn right on Seaglen Dr.
3	Turn right on Napier Rd.	15	Turn right on Napier Rd.
4	Turn left on Seaglen Dr. (enter Island Lake Subdivision)	16	Turn left on Eleven Mile Rd
5	Turn left on Drakes Bay Dr.	17	Turn right on Johns Rd.
6	Turn left on Terra Del-mar Dr.	18	Turn left on 12 Mile Rd.
7	Make a loop on Terra Del-Mar	19	Make u-turn .3 mile past Hass Rd
8	Turn right on Drakes Bay Dr.	20	Running toward east on 12 Mile Rd.
9	Turn left on Reeds Pointe Dr.	21	Turn right on Johns Rd.
10	Continue left on Reeds Pointe Dr.	22	Turn right on South Lyon East HS
11	Take the trail by the lake	23	Finish at the 50 yard line on Football Stadium
12	Trail turns to Shoreline Dr.

5K and 10K courses have the same start and finish as Half-marathon but will return at half way mark.
