## **BACKGROUND INFORMATION:**

On September 28, 2015, City Council approved to award a contract for architectural and engineering services to Fishbeck, Thompson, Carr & Huber, Inc. (FTC&H) for the preliminary design, final design, bidding, and construction administration phases for the new Pavilion Shore Park restroom/shelter building in the amount of \$36,360.

In keeping with the City's desire that the design of the pavilion should be a contemporary structure with some reference to the historical legacy of the previous Walled Lake Casino, FTC&H focused on those aspects of the previous structure that would be deemed "iconic" to the appearance of the building and still aesthetic pleasing to the surroundings. FTC&H has reviewed schematic design and developed an opinion of probable construction cost including restroom facilities in the 49 feet long by 31 feet wide structure.

Total estimated construction costs including materials, labor, surveying, soil borings, bonds, contingencies, etc., is estimated to be \$484,971. The initial amount awarded for architectural and engineering services is being adjusted to cover the additional estimated construction costs.
