Member Mutch noted his concerns at the FIRST READING regarding the language of the ordinance. He knew staff looked at alternative language or an addition to the language to further limit the locations. They felt it wasn't necessary and he was comfortable allowing this to move forward as proposed. He addressed the Planning Commission to review the zoning ordinances to find appropriate locations for similar uses. He thought that when some of the uses get to a certain size, they have a significant impact on the surrounding residential areas. He questions if they are appropriately located within all of our zoning districts. City Attorney Schultz said the project will proceed to the Planning Commission with this option.

Member Mutch made a request for the Planning Commission to review the City zoning standards related to places of worship and similar uses, specifically, to see if there are appropriate locations in the City for the larger uses. He didn't have any specific numbers, but the question of the larger uses with significant traffic impacts remained. He noted there may be locations along the Grand River Corridor or the 12 Mile Corridor and not in a residentially zoned district that may be appropriate for larger uses. He hopes uses of that nature, that want to come into Novi, will be appropriately sited. He asked Planning Commission to make recommendations for zoning text ordinance amendments to come back to Council. He didn't have a timeline.
