BACKGROUND INFORMATION: The new 2021 Chevrolet Suburban will be replacing vehicle #339, a 2016 Chevrolet Suburban with almost 100,000 miles. This vehicle is used by the Fire Department as an incident command vehicle. The current union contract requires public safety vehicles to be removed from emergency service at 100,000 miles.

Retrofits include a thermal imaging camera, which allows the Incident Commander to conduct a 360-degree scene overview to locate hot areas from a fire or a possible victim in a structure. Additionally, an equipment divider is included to organize the large rear compartment area.

The anticipated time of delivery is February 2021.

RECOMMENDED ACTION: Approval to purchase one (1) 2021 Chevrolet Suburban and retrofits for the Novi Fire Department from Berger Chevrolet through the Oakland County Cooperative purchasing contract in the amount of \$77,179.54.

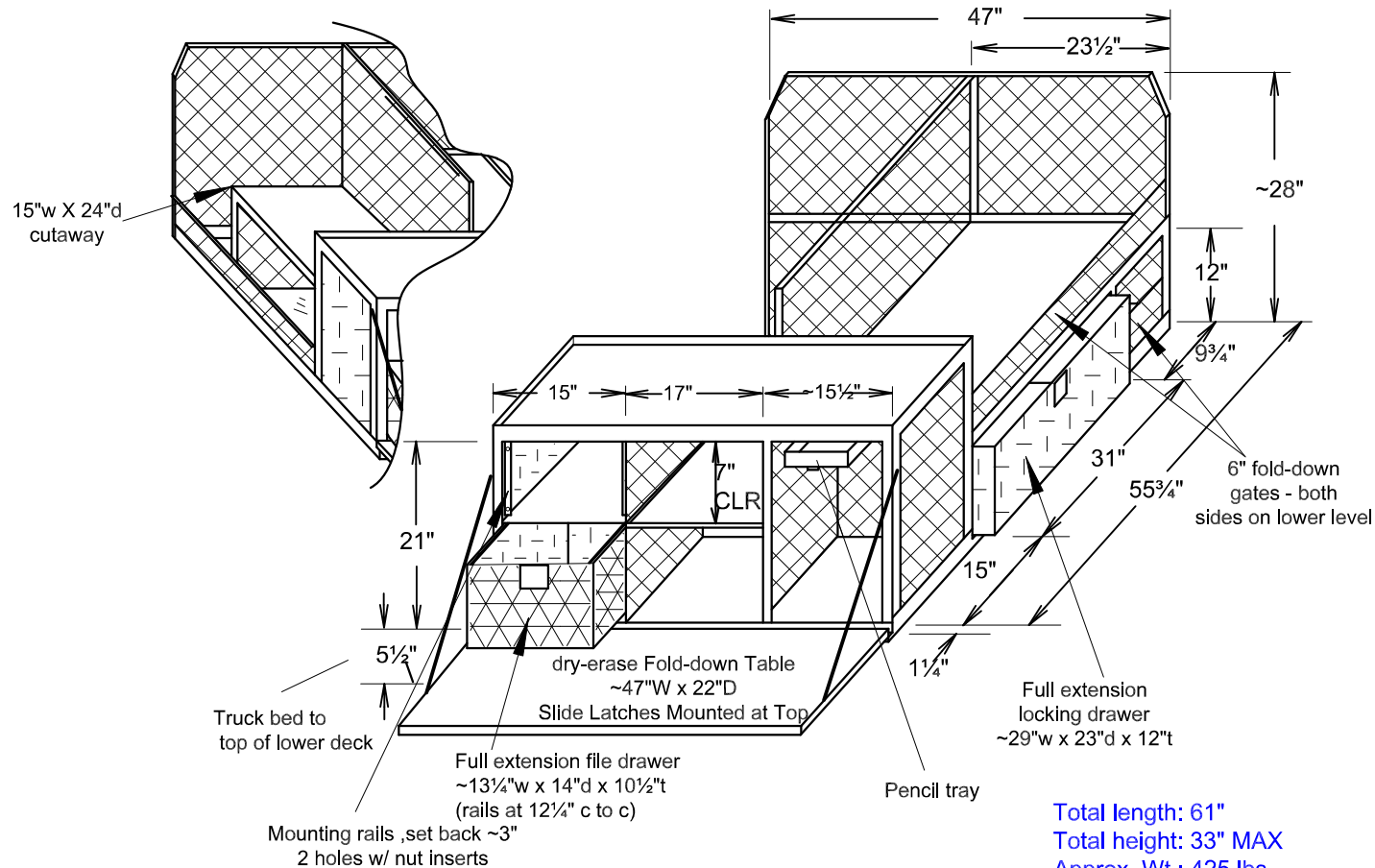
