SUBJECT: Approval to award an amendment to the engineering services agreement with URS Corporation for additional construction engineering services for the Grand River Avenue Right Turn Lane Extension (at Beck Road) in the amount of \$33,760; and approval of a resolution to amend the budget to add \$33,760 to this line item.

BACKGROUND INFORMATION:

The extension of the existing westbound right turn lane on Grand River Avenue approaching Beck Road received a federal congestion mitigation air quality improvement grant for 2014 construction. The grant was capped, but was to cover 80% of the estimate construction costs for the project. The City approved a cost participation agreement with Michigan Department of Transportation (MDOT) on July 21, 2014 in advance of the construction bid opening on August 1, 2014. MDOT handles bidding and contract administration for all federally funded projects. Staff learned during the bid process that MDOT had selected this project to be restricted only to contractors participating in the Small Business Program. The low bid was 24% over the engineer's estimate; however, staff recommended proceeding with the project in order to get it completed in 2014 as intended, especially since the additional cost to the City was minimal because of the grant.

The low bidder for the project, Hart & Associates, spent several months working with MDOT to provide the required bonding and insurance to proceed with award of the project. It wasn't until March 12, 2015 that MDOT finally awarded the project; seven months after bids were opened. Throughout this delay, staff was in contact with the top management at MDOT at Metro Region and in Lansing urging them to either award the contract to the next low bidder or to expedite the bonding process with the low bidder. As part of the Small Business Program, MDOT opted to work with the low bidder to provide the necessary paperwork.

The project was awarded to Hart & Associates on March 12, 2015 and they provided a progress schedule showing that construction would commence on April 17, 2015, would be open to traffic on May 12, and meet the contract completion date of May 30. The project wasn't actually open to traffic until June 23 and is still not fully complete, a full year after the project was bid. The contractor made very slow progress in completing the work and several times had to remove and replace recently completed work due to errors or other workmanship related issues.

The delays on this project have resulted in additional time by the City's consultant not only for construction engineering work but also for inspection. As a small business project, MDOT offered weekly pay estimates to the contractor instead of bi-weekly, which resulted in not only double the number of pay estimates to process, but even more estimates because the project has been open for so long. Additionally, the contractor had to re-do several work items and made slow progress resulting in additional inspection time beyond the budget prepared by staff for a typical project.

The federal grant for this project is capped; therefore all additional costs for this project are the responsibility of the City as the requesting party. The City has filed a claim for liquidated damages in line with MDOT's standard specifications in the amount of \$22,000 (the maximum allowed) to help the City partially offset the additional costs that we have incurred as a result of the Small Business Program and the contractor. Staff is awaiting a decision from MDOT on the status of this claim. Staff has also requested that MDOT find additional funds to uncap the grant and offset the additional costs to the City resulting from this project.

Staff has reviewed the attached requests for additional services and recommends award. Since these additional funds are not budgeted, a budget amendment resolution has been prepared to recognize additional property tax revenue and a reduction in chargebacks to offset these increased expenditures.

We will continue to work with MDOT and the contractor toward final completion of the project this summer and resolution of any claims.
