BACKGROUND INFORMATION:

Over the past four years the Civic Center facility has undergone numerous Department office renovations. The Community Development department is nearly the last location in the building that holds most of the original office furnishings that date back to 1987. We engaged targeted staff in an exercise to provide feedback as to what tools and design elements would be beneficial to completing their respective job functions. This adjacency data along with the services of a professional space resource planner, architect, and the affected department directors lead to a recommendation of the proposed suite layout.

The project scope will include the installation and purchase of new flooring. The proposed flooring is manufactured by Patcraft, providing durability with functionality and will provide a clean modern look allowing a state of the art environment for our Citizens and staff.

The pricing is based on the National Joint Powers Alliance (NJPA) cooperative purchasing contract. Contract and product information are attached.




