## A Letter from our WMHA President

Hope this newsletter finds you well. Summer is a great time to enjoy our beautiful subdivision. I cannot help but notice the positive updates some residents have been making to the exterior of their properties. Please touch base with our Architectural Control director, Matt Hannah, before embarking on structural changes to your home exterior or property.

As you know the City of Novi has awarded our trash collection to a new company, GFL. We have all had to deal with four large trash receptacles for several weeks. Once the old receptacles are picked up, per our CC&Rs and city ordinance, the two remaining receptacles "...must be placed within a totally enclosed building or placed upon an area of the rear yard of the occupant's property...." Visit cityornovi.org/trash for details. You can avoid an awkward conversation with your neighbor, an Association Board member, or a city compliance officer by following this simple rule. The Association CC&Rs are designed to keep our community well-kept and desirable.

The Board cannot help but notice there are several homes not in compliance with the landscaping CC&Rs. Overgrown landscape and weeds are not only unsightly, but they deter from curb appeal in our community. The Board will continue to address these concerns with individual homeowners until properties are compliant. We all benefit by beautifying our properties and enhancing our curb appeal.

As I mentioned in my last article, the Board is working with attorneys to clarify CC&Rs language. They are a couple weeks away from delivering those updates.

Although goose traffic has been down noticeably this year, Goose Busters have identified 3 families of Canada geese which are coming over from Haggerty through Crosswinds. We are hoping they will be gone soon. The projection for next year is a significant reduction. We set our current contract for only 9 months, due to our small budget and would be looking to increase to a 12-month contract, if needed.

Second request 2021 dues invoices were mailed out on April 15th with an "on receipt" due date. 318 out of 338 homeowners (94.08%) have paid their 2021 dues. The 3rd dues reminder will be mailed out on July 15th with a \$5 late fee added. We have six residents who have one year (2020) in back dues. Paying on time reduces costs for the Association and allows us to pay for common services. It has been several years since dues have been increased, but with our increased costs of services I am anticipating a Board increase for 2022 within our Bylaws.

Your Board meets monthly to address Association business. All questions and comments which come to the Board get discussed at these meetings. Any decisions are communicated back to the resident.

To be proactive and make sure you are not slowed down, request this document when you first decide to put your home up for sale. Also, verify your home is compliant of all WMHA rules and regulations to ensure nothing will hold your home sale from occurring. We will provide any documentation needed and assist you in any way we can. Best wishes.

# **New Disposal Service**

By now you should have received a new garbage bin and recycling bin. The City of Novi has partnered with GFL Services. If you have any questions and/or concerns please contact the city.

We thank you for continuing to follow City of Novi and the WMHA regulations.

As a reminder the City of Novi issued the following information:

Per city ordinance, you should not put out waste or recycling bins earlier than 24 hours prior to the scheduled collection day. It is the responsibility of both the property owner and the property occupant to place refuse at the designated collection site within a refuse bin sealed container or plastic bag to prevent objectionable odors, or spillage of refuse upon any public or private site. All receptacles must be removed from such areas no later than 12 hours following the actual collection. Trash receptacles must be placed within a totally enclosed building or placed upon an area of the rear yard of the occupant's property so as not to create a nuisance to surrounding residents.
