## BACKGROUND INFORMATION:

The design engineering for improvements to the Regency lift station and the Knightsbridge Gate lift station was approved in March 2014 and was recently awarded for construction. The project involves installation of natural gas powered generator sets at the lift stations. A natural gas powered generator is more efficient than diesel powered at this size and would not requiring refilling the diesel tanks from city personnel since the natural gas is supplied by the natural gas utility.

The lift stations were constructed by the respective developers and a portable off-site generator was provided to the City for each. A permanent generator at these locations would provide backup power immediately to better prevent sanitary sewer back-ups caused by power failures without relying on the delivery of the portable generator by City personnel.


The Taft Knolls lift station is located on Taft Road south of 11 Mile Road and also requires the installation of a permanent on-site generator set. Because the scope of the project is similar, staff recommends adding Taft Knolls to the project and award of the design engineering to Spalding DeDecker, the consultant for this project. The design will occur upon award and construction would be completed with the rest of the project.

Recent lift stations that have been constructed by developers have included on-site generators at the City's request.

## SECOND AMENDMENT TO THE SUPPLEMENTAL PROFESSIONAL ENGINEERING SERVICES AGREEMENT

## 2015 LIFT STATION UPGRADES (FORMERLY KNOWN AS REGENCY CENTRE AND KNIGHTSBRIDGE GATE LIFT STATION UPGRADES)

Second Amended Agreement between the City of Novi, 45175 W. Ten Mile Road, Novi, MI 48375-3024, hereafter, "City," and Spalding DeDecker Associates, Inc., whose address is 905 South Boulevard East, Rochester Hills, MI 48307, hereafter, "Consultant," relating to modifications of the fee basis for engineering services. The following sections of the Supplemental Professional Engineering Services Agreement, as made and entered into on March 24, 2014 shall be amended as follows:

<u>Section 2. Payment for Professional Engineering Services.</u> The following Paragraphs shall be amended as follows:

- 1. <u>Basic Fee.</u>
  - Delete 1.a. in its entirety and replace with the following language:
    Design Phase Services: The Consultant shall complete the design phase services as described herein for the lump sum fee of \$35,300.
  - b. Unchanged
- 2. Unchanged

Except as specifically set forth in this Second Amendment, the Supplemental Professional Engineering Services Agreement remains in full force and effect.
