BACKGROUND INFORMATION:

Interphase Land Development, the developer of Casa Loma subdivision currently under construction, is requesting acceptance of the completed boardwalk in the existing public right-of-way along the west side of Beck Road, north of Eight Mile Road. The referenced boardwalk has been constructed to City standards and will now fall under the City's maintenance program.

The enclosed boardwalk Bill of Sale has been favorably reviewed by the City Attorney (Beth Saarela's November 9, 2016 letter, attached) and is recommended for approval.




