SUBJECT: Approval to award an amendment to the engineering services agreement for the 14 Mile Water Main project with Spalding DeDecker Associates for design engineering services for the 14 Mile Pathway Construction project in the amount of \$17,605, and approval of an additional appropriation in the amount of \$17,605 for this budget line item.

BACKGROUND INFORMATION:

City Council approved a motion at the May 11, 2015 regular meeting directing staff to prepare a budget amendment in the first quarter of FY15-16 to add the construction of pathway segment 129 along the south side of 14 Mile Road between Haverhill Farm Subdivision and the Maples of Novi. A previous design award was made to Spalding DeDecker on March 23, 2015 for the construction of a water main along the south side of 14 Mile Road and included a small fee to develop a concept plan and budgetary cost estimate for the pathway. Although the water main and the pathway would be located along the same segment of 14 Mile Road, they are not likely to be constructed in the same location due to conflicts with DWSD's water main along 14 Mile Road and topographical constraints. However, it is possible to construct the two projects at the same time using the same contractor to save costs on excavation and restoration. Staff recommends awarding design at this time if there is any possibility of constructing the pathway this year, which is dependent also on easement acquisition.

The design fee for the pathway construction is based on a reduced fixed fee schedule from that which was established in the Agreement for Professional Engineering Services for Public Projects for the City's three pre-qualified engineering consultants. The design fee was reduced by 3% because the concept plan and topographic survey were already completed. The design fees will be \$17,605 (7% of the estimated construction cost of The construction phase engineering will be awarded at the time of construction award and will be based on the contractor's bid and the fee percentage in the Agreement for Professional Engineering Services for Public Projects. A draft of the First Amendment to the Supplemental Professional Engineering Services Agreement for the project is enclosed.

Design of this project would begin following award, and construction could occur this year barring any prolonged issues with easement acquisition.



<u>FIRST AMENDMENT TO THE</u> SUPPLEMENTAL PROFESSIONAL ENGINEERING SERVICES AGREEMENT

14 MILE WATER MAIN EXTENSION AND PATHWAY CONSTRUCTION (HAVERHILL TO MAPLES OF NOVI)

First Amended Agreement between the City of Novi, 45175 W. Ten Mile Road, Novi, MI 48375-3024, hereafter, "City," and Spalding DeDecker Associates, Inc., whose address is 905 South Boulevard East, Rochester Hills, MI 48307, hereafter, "Consultant," relating to modifications of the fee basis for engineering services. The following sections of the Supplemental Professional Engineering Services Agreement, as made and entered into on March 23, 2015 shall be amended as follows:

<u>Section 2. Payment for Professional Engineering Services.</u> The following Paragraphs shall be amended as follows:

1. Basic Fee.

- a. Design Phase Services (Water Main Extension): The Consultant shall complete the design phase services as described herein for a lump sum fee of \$10,140, which is 9.75% of the estimated construction cost (\$104,000) as indicated on the Design and Construction Engineering Fee Curve.
- b. Design Phase Services (Pathway Construction): The Consultant shall complete the design phase services as described herein for a lump sum fee of \$17,605, which is 7.0% of the estimated construction cost (\$251,500).

2. Unchanged

Except as specifically set forth in this First Amendment, the Supplemental Professional Engineering Services Agreement remains in full force and effect.
